No opposition in Town races

No opposition has emerged for this year's Town and Sanitary District races.

Town Chairman

Town Chairman Robert Schmeichel is seeking his third term as Town Chairman. Schmeichel has lived in the Town since 1984. He joined the Park Board in 1986 and moved to the Plan Committee (now Plan Commission) in 2003, where he subsequently served as chairman.



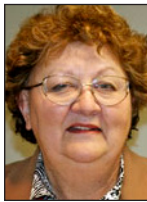

Schmeichel is a former president of the Wisconsin Chapter of the American Society of Landscape Architects, and a former member of both Neenah Rotary and the Fox Cities Greenways board.

Town Supervisors

Supervisors Jan DeKeyser and Geoff Hibner are seeking re-election this year.

Jan DeKeyser, a 50-year Town resident, has served on the Town Board for the past 18 years. She was appointed to the Park Board in 1980 and became chairman in 1985 - a position she continues to hold. She has also served as secretary/administrator of Sanitary Districts #2 and #3 since 1990.

DeKeyser serves on the board of directors of the Wisconsin Utility Tax Association and on the Urban Towns Committee of the Wisconsin Towns Association.

Geoff Hibner is the former chief financial officer of Banta Corporation. He has served on the Town Board for five years. Hibner has been a resident of the Town for the past eight years and has an extensive business background.

Sanitary District Commissioners

Both Sanitary District #2 (which includes most of the Town's sewerage area) and Sanitary District #3 (which includes parts of the Town's north end) have one seat up for election to their respective three-member commissions.

In Sanitary District #2, Steve Spanbauer is seeking a new term. Spanbauer has served on the Sanitary District board for many years. He is also a former Town of Neenah Chairman.

No one filed papers to be on the ballot in Sanitary District #3. Bryan Von Deylen, whose term is expiring, may seek re-election as a write-in candidate.

Sanitary District commissioners serve six-year terms.

Spring 2013 election facts:

Elections will be held April 2, 2013, for the purpose of electing Town and Sanitary District officials (see above). Residents will also elect three members to the Neenah school board (four candidates running), a Winnebago County Executive (incumbent unopposed), a state Supreme Court justice (incumbent and two challengers), and a state Superintendent of Schools (incumbent and one challenger). There will be a primary on Feb. 19 for the Supreme Court race.



The Town of Neenah Fire Department will be celebrating its 75th anniversary this year, and I thought it would be interesting to look back at its early days. The Fire Dept. was formed in 1938, however the Town of Neenah was created by Wisconsin Territorial legislation on Feb. 11, 1847.

That means for the first 91 years of the town's existence, we did not have a fire department (rather scary when you think about all of the old wooden structures, wood-burning stoves, and lanterns in use back then). If any of you have any old history of the Fire Dept. (maybe your grandfather was a volunteer fireman), please contact me.

In doing my research, I found some interesting information on the early days of the Town, so I will start with that, and then move on to the history of the Fire Dept. in the July newsletter. I hope to do an article in each quarterly newsletter.

The first information I found is from 1855. Remember, the City of Neenah did not exist; all land now occupied by the City was the Town of Neenah and later, the Village of Winnebago Rapids.

April 1855

The Board met at Weedens Hotel on April 3, 1855. It was moved and carried that \$700 be raised for roads and bridges, \$200 for the support of the poor, and \$150 for contingency expenses.

September 1855

Supervisors met to receive and open bids for the building of the Slough bridge (most likely at Main St.). The Board resolved to accept the bid of Smith and Bowen to build a "good and substantial bridge" across the Slough for the amount of \$700:

"Be it resolved the bridge should not be less than 5 feet from the surface of the water and should be level from end to end. The contractor shall grade down the bank at each end, to be level with the bridge for 2 or 3 rods at each end."

April 1856

The Board resolved that \$600 be appropriated, under the direction of the supervisors, for grading and plowing roads on Doty Island, provided a like sum is raised and expended by the Town of Menasha.

April 1859

The Board authorized receiving labor in place of cash in payment for highway taxes.

April 1860

Moved and carried that the business of doctoring the poor be let to the lowest bidder. All medical attendance, medicine, and surgery shall be included in one contract. Dr. Robinson won the contract to tend to said poor for the sum of \$96, to be paid in quarterly installments of \$24 each.

During my tenure serving the Town of Neenah, I have received calls and have had conversations with concerned town residents on a variety of Town-related issues. With the help of the good people that hold various positions in our Town government, I try my best to follow through on information requests. However, I would offer that most of the information requested can be easily obtained at any one of the Town's "open to the public" meetings. Whether that be a meeting of the Town Board, or Plan Commission, or Park Board, etc., all are posted on a regular basis and are open to the public.

At latest count, the Town of Neenah has a population of 3,306 residents. The highest proportion of those residents are in the range of 35 to 65 years of age. I fully realize that we all have busy personal lives and other commitments, but when is the last time YOU attended any Town meeting?

So as that guy says on TV; "Come on down..." It will enlighten you and can be at times "entertaining."

Wintertime snow

A "fun snow fact:" According to specialists, "snowflakes are agglomer-

ates of many frozen ice crystals, most snowflakes are less than one-half inch across."

The water content of snowflakes is more variable than we think. An average snowflake is made up of 180 billion molecules of water, but the snow-water ratio depends on various factors such as temperature, crystal structure, wind speed, etc.

Even if there aren't any images of the biggest snowflake ever recorded, the *Guinness Book of World Records* states that a giant snowflake was found at Fort Keogh, Montana, on Jan. 28, 1887. It was 15 inches wide and eight inches thick. WOW! How'd you like to have flakes of that size piled in your driveway?

As a reminder to everyone, there is a no parking ordinance on Town of Neenah roads and rights-of-way from Dec. 1 to April 1, from 2 a.m. until 7 a.m. Although we had fair warning of our first snow event of the season, there were a few vehicles that the county snow plows had to maneuver around to plow the roadways. *The county snowplow trucks need a clear roadway for the snowplows. Any vehicle parked on town roads or rights-of-way during the specified times will be removed at the owner's expense and be fined.*

Also, those town residents that have placed wooden or steel stakes along

the shoulder of the road at the grass line need to remove them. Snow plow drivers need to have the entire shoulder and some of the town right-of-way clear of obstacles so that they can completely clear the road of drifting snow.

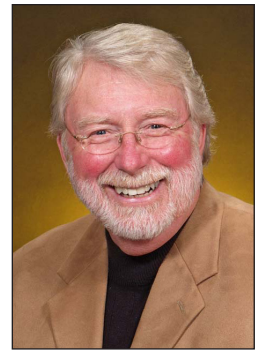
And last but not least, after any snow event, let's all please help out the mail carriers by shoveling the windrowed snow away from your mail box so the carrier has easy access to the box.

New fire truck enters service



The Town of Neenah Fire Department accepted delivery of its new tender (water tanker) in early December. The truck is needed to

deliver water to fire scenes where there are no hydrants. The truck cost \$253,144, and replaces a tanker purchased 28 years ago.

New shelter fund

Several Town residents have contributed to a special fund earmarked for the construction of a shelter building at Franzoi Park. The Town Parks Committee has advocated the shelter to serve the park in the Town's most rapidly-growing area. The committee estimates the shelter cost to be around \$250,000. It would be similar to the shelter at Mahler Park, and would include indoor restroom facilities.

The Town cannot afford the cost at this time, but the Board set aside \$15,000 in the 2013 budget to start a shelter fund. Individuals are encouraged to donate to the Franzoi Park shelter fund; such donations are tax-deductible. Donations can be mailed to the Town Hall.

Town of Neenah taxes still lowest in region

The Town's budgeted expenditures for 2013 are \$1,175,011. This is essentially the same as in 2011, and down substantially from 2012, when there were extraordinary expenses for the completion of the South Park Avenue retention pond and conservancy park and for the purchase of a new fire truck.

Also, last year the Town paid off some long-term debt, which will reduce 2013's debt service by more than \$100,000.

Revenue sharing from the state is expected to drop by more than \$25,000

in 2013, but by holding the line on expenses, the Town needs to increase its total property tax revenue by only \$8,522.

The Town of Neenah's portion of your tax bill thus increased by less than \$.01 per \$1,000 of assessed valuation, and stands at \$1.14 per \$1,000 – the lowest in the area! For comparison, the rate in the similarly-sized Town of Clayton is more than double the Town of Neenah's rate, at \$2.49 per \$1,000. The Town of Menasha's rate is \$5.34 per \$1,000, and the City of Neenah's

rate is \$9.09 per \$1,000.

The Town of Neenah's annual charge for stormwater was dropped from \$78 to \$55 for a single-family residence (Equivalent Runoff Unit – ERU), with a comparable reduction for other property types. The Town is reluctant to build up an excessive stormwater fund at this time due to uncertainties over eventual rules to be set by the Wisconsin Department of Natural Resources (DNR).

Dog licenses due

Owners of dogs more than five months of age on January 1 of any year, or five months of age within the license year, shall annually, on or before the date the dog becomes five months of age, pay the dog license tax and obtain a license (Wisconsin Statute 174.05). Dog licenses issued for 2013 will be valid through Dec. 31.

The fees RE \$5 for a neutered male or spayed female and \$10 for an un-neutered male or unspayed female. There is an additional \$5 fee if paid after April 1.

When applying for a license, please present the animal's current rabies vaccination certificate certified by a licensed veterinarian.

All checks should be made payable to the Town of Neenah and mailed or dropped off at the Town Hall, 1600 Breezewood Dr., Neenah 54956.

Snowfall reminders

- There is no parking on Town roads between 2 a.m. and 7 a.m., from December through March.
- Check your mailbox – is it stable enough to survive the winter?
- Don't plow snow across the road when cleaning your driveway.
- Don't place markers in the road right-of-way. We must have a place to push the snow.
- Don't place your garbage or recycling containers in the road-way where they could be struck by a snowplow.
- Don't park on the road *at any time* during a snow event.
- Don't lose patience with our snowplow drivers. They do not have an easy job.

Town of Neenah Recycling Schedule

If you live WEST of Highway 41 or NORTH of Winneconne Ave. (JJ/114), your recycling and trash pickup day is TUESDAY. Trash is picked up every week; recycling is picked up every-other week. If you live between County Hwy. JJ/Winneconne Ave. and Larsen Road, you are GROUP A. If you live north of Larsen/ Oakridge or south of JJ/Winneconne, you are GROUP B.

If you live EAST of Highway 41 and SOUTH of Winneconne Ave. (JJ/114), your recycling and trash pickup day is WEDNESDAY. Trash is picked up every week; recycling is picked up every-other week. If you live south of Bell St. and west of the Hidden Acres subdivision, you are GROUP A. If you live anywhere else in this area, you are GROUP B. Maps are available on the Town's website or at the Town Hall.

Please remember the following recycling-collection requirements:

- 1) Only Veolia-supplied carts will be emptied
- 2) Carts should be placed at the curb by 6 a.m. on your collection day.
- 3) Carts must be facing the street as indicated by arrows on the cart lid.
- 4) *Please leave at least five feet of space between your cart and any other object, such as a light pole, mailbox, or other trash/recycling cart.*
- 5) Veolia will not pick up trash or recycling that does not fit inside the cart. Lids must be closed to be serviced. Material outside the cart will NOT be collected.
- 6) Please bag your trash to prevent loose materials from blowing out.
- 7) Recycling must be *loose in the cart -- no plastic bags or stringed paper bundles.*

8) Please do not tightly stuff or compress material into the carts, as the carts may not completely empty into the truck. The truck will not return for carts that did not empty.

9) Electronic waste (TVs, radios, VCRs, DVD players, computers and computer parts, cell phones, etc. will NOT be accepted. Please take all such items to the Winnebago County landfill or to an e-recycling facility.

10) No oil, oil filters, or oil-absorbent materials.

11) No grass clippings, yard waste, Christmas trees, or ashes will be accepted.

12) No hazardous wastes will be accepted.

Renew Our Waters

Every choice counts.

Ice and Snow Control

We can have safe walkways in the winter and cleaner water all year round.

Winter in Northeast Wisconsin is a great time for outdoor fun, like ice fishing, ice skating, sledding and skiing. Here, winter also means mountains of snow to shovel and layers of ice to remove from driveways and sidewalks.

We often try to make ice removal easier by using products like salt and sand to melt the snow and ice. Many people do not realize that these products are harming local waters and the animals that rely on them. When the ice and snow melt, the salt and chemicals flow into street drains that lead directly to rivers and lakes.

SHOVEL OFTEN AND EARLY

Shoveling often during and immediately following the storm removes the snow from walkways and driveways before it gets packed down by tires and feet. The most important part of deicing is removing as much snow as possible before applying salt or sand - it's also great exercise!

Use only the recommended amount.

Throwing down more salt will not speed up the melting process.

MAKE THE MOST OF THE SALT YOU USE

It is not always necessary to see bare pavement to have a safe winter surface. Ask yourself if it is necessary that the snow or ice be removed. For salt to be effective, air temperature needs to be warmer than the surface temperature of the area you want to treat. A little goes a long way. Use only the recommended amount. Throwing down more salt will not speed up the melting process. Use only enough deicer to break the bond between the ice and the pavement, then remove the remaining slush by shoveling.

LIMIT THE AMOUNT OF SAND YOU USE

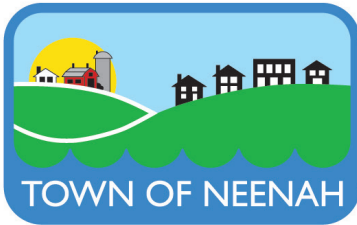
Sand provides traction. It does not melt ice. Sand, although not chemical, contributes to polluting our local waters. It adds to the excess sediment that is entering waterways, eliminating important habitat for aquatic plants and animals. Sand does play a role in winter road management. It is often used by municipalities on roads to help maintain traction. Since ice removal is typically the concern of homeowners, sand may not be necessary.

Stormwater is rain or snowmelt and water from things people do, like overwatering the lawn or washing the car on the driveway. This water runs off our properties, into the street and down the storm drain - picking up pollutants on its way. Once it reaches the storm drain the water and the pollutants it carries is discharged into local waterways.

Untreated runoff is the biggest threat to our nation's water quality, according to the U.S. Environmental Protection Agency. Let's make the small, important changes that will reduce that threat and improve water quality and our lives!

BURNING: Burning is permitted in the Town of Neenah, but the Fire Department requests that you use common sense (dryness and wind are always factors to watch), and that you call the Winnebago County Sheriff's Office non-emergency number (236-7300, #0) before and after burning to avoid false alarms. Please be considerate of your neighbors when burning, making sure the smoke isn't blowing in their direction. Burning garbage is prohibited.

MINUTES AND AGENDAS: Town minutes and agendas are posted on the Town website (<www.townofneenah.com>) and are also available for inspection at the Town Hall during regular business hours.

ADDRESS SIGNS: Homeowners are responsible for maintaining the emergency address signs placed in front of their homes by the Town. Assure that the signs remain visible by keeping brush and snow away from the sign. Also, do not remove or relocate the sign.

DEER/WILDLIFE PROBLEMS: The Town has no authority to handle wildlife problems. If you see a dead animal on the road call the County Sheriff at 236-7300, ext. 8. If you have other wildlife problems, call a private pest/wildlife control service.

OBSTRUCTING RIGHTS-OF-WAY AND DRAINAGE DITCHES: You cannot place a fence or greenery in the Town's road right-of-way. No part of a mailbox should extend over the paved portion of the road. In addition, culverts and drainage ditches must be kept clear of obstructions and must not be filled in. If you have a question about water drainage issues or the right-of-way, call Town Chairman Robert Schmeichel.

BUILDING PERMITS: All building permits are issued by Building Inspector Gary Klinka (727-9200). Permits are needed to construct a fence or build a deck. If you aren't sure you need a permit, check with Gary.

RECYCLING: All town recycling is picked up every-other week, depending on where you live (see page 6). All recyclables to be picked up must fit inside the container supplied by Veolia. They will not pick up bagged or boxed items, or recyclables in other containers. Please do not wrap items with string or place anything inside plastic bags. Electronics, waste oil, and other materials may not be placed with your recyclables or in the trash.

DOGS: All Town of Neenah dogs must be licensed. The license is issued by the clerk/treasurer. The cost for neutered/spayed dogs is \$5; all others are \$10. Dogs cannot run at large. They must be confined to your property or on a leash and under your control if off the property. NOTE: Leashed dogs are allowed in Town parks provided you immediately pick up any waste.

WINTER PARKING BAN: The Town has an ordinance prohibiting parking on Town roads between 2 a.m. and 7 a.m., from December 1 through March 31.
