The Good Ol' Days

March 10, 1869

Resolved by the Board of Supervisors of the Town of Neenah, Wisconsin, that the sum of five dollars be, and the sum is hereby fined, and established as the penalty for each and every person or persons riding or driving faster than a walk across or on the bridge across the south channel of the Fox River in said town.

February 17, 1876

Chattel Mortgage Releases State of Wisconsin Town of Neenah

To Whom it May Concern: In a certain chattel mortgage given by Alfred and John Millard to Albert Huxley about the first of last November, to secure a note given by them, to him, one colt named Charlie. Now we the undersigned desire to release the mortgage on said colt, and to place it, in his stead, on three cows owned by the said Alfred and John Millard, known as the Fenton cow, the Danby cow, and the Red Haylet cow. Wisconsin Fireworks Laws and Regulations

As we look forward to the warmer days of summer and



the many outdoor activities that come with it, many of us may be already looking forward to the long 4th of July weekend and planning activities or family gettogethers. Included below are excerpts from the State of Wisconsin laws regarding the use of fireworks and what is legal and what is illegal,

What Fireworks are legal? State law allows the sale, possession and use, without a permit, of sparklers not exceeding 36 inches in length, stationary cones and fountains, toy snakes, smoke bombs, caps, noisemakers, confetti poppers with less than ¼ grain of explosive mixture, and novelty devices that spin or move on the ground. Wis. Stat. § 167.10(1). There is no age restriction on sale, possession or use of these devices and the statute does not classify them as fireworks. These are the only kinds of "fireworks," as that word is commonly used, that a person may use or possess without a permit or that may be sold to a person who does not have a permit.

What Fireworks are illegal? Possessing or using any other fireworks, including, for example, firecrackers, roman candles, bottle rockets and mortars, in Wisconsin without a valid permit is illegal. Wis. Stat. § 167.10(3). A commonly used rule of thumb is that a permit is required if the device explodes or leaves the ground. The sale of these restricted fireworks to a resident of this state without a valid permit is also illegal. Wis. Stat. § 167.10(2). Only the jurisdiction, where the fireworks are to be used can issue a permit for use. The Town of Neenah has not and does not intend to issue permits for fireworks use

by individuals or groups. With this in mind, fireworks use in the Town of Neenah is illegal.

What are the penalties for using fireworks without a permit? A person who possesses or uses fireworks without a valid permit, or who sells fireworks to a person who does not have a valid permit, is subject to a forfeiture of up to \$1,000 per violation. Wis. Stat. § 167.10(9)(b). Each firework illegally possessed, used or sold may be a separate violation. A parent or guardian who allows a minor to possess or use fireworks (not including those for which no permits are required) is subject to a forfeiture of up to \$1,000 per violation. Wis. Stat. § 167.10(9)(c). A city, village or town may obtain an injunction prohibiting a person from violating Wis. Stat. § 167.10(8)(a). Violations of such an injunction are criminal misdemeanors, subject to up to 9 months in jail and a \$10,000 fine. Wis. Stat. § 167.10(9)(a).

What should I do if I see or hear fireworks being used near my home? Hopefully, if it is a neighbor, you can have a reasonable conversation with them and ask them to stop. If that is not effective, you may want to call the Winnebago County Sheriff's Department. Obviously calling law enforcement on a neighbor may not be the best option for long term relations with an individual and hopefully the initial conversation will help you get your point across so that they understand your concerns.

The use of fireworks is dangerous and each year there are many emergency room visits that may have been avoided had better judgment been used. In addition, across the state there have been several serious fires from smoldering debris falling onto roofs and vehicles. Several years ago in the city of Madison, a large apartment building was destroyed by fire as the result of illegal fireworks use.

In closing, the best and safest option to view fireworks is to attend one of the many municipal displays in the area, which are put on by professionals and supervised by local police and fire agencies.

The Perfect Lawn

You can create a beautiful outdoor space and protect our waters

A gorgeous home landscape doesn't need to come at the price of clean lakes and streams. We can have both. But to make it happen, we all need to think a little differently. Read these tips. Post this sheet in your garage near the lawnmower and garden tools. This will help us change one habit at a time, so we have good fishing, swimming, paddling and waterskiing when the work is done.

Mowing

Mow often, when the grass is 3.5 inches or shorter. Set your mower blade at 2.5 inches and let cuttings fall. Cuttings keep the soil moist and restore nutrients over time. Any mower works, but a mulching mower shreds grass finely, so you don't have to be as careful about grass height.

A healthy, mulched lawn outcompetes weeds for light, nutrients, and water. In areas where it's hot, consider prairie grasses or wild flowers instead of turf grass.

Make an effort not to blow cuttings onto pavement. If you do, sweep them up, then lay them around the roots of shrubs or vegetable plants where they help retain moisture.

If grass gets long and you decide to collect clippings, put them in a pile with other yard waste and let them decompose. Turn the pile now and then, and in 3-6 months you'll have rich organic matter that will make almost anything in your yard grow better.

FERTILIZING & WEED CONTROL

Chemicals and weed killers are not needed for a healthy lawn, and they're one of the main reasons we have green algae in our lakes and streams.

Think before you buy. Get a soil test so you know if your lawn needs more nutrients. Mulch to keep the lawn healthy, so it can outcompete weeds for light, nutrients and water. If you must fertilize, do it in the fall. Sweep up fertilizer that falls in the street and dispose of it properly—water and fertilizer that go into the street go directly to the river or lake.

WATERING

When watering is needed, use a sprinkler that shoots low to the ground. Sprinkle soil, not the street. Shape soil so water will sink in, rather than run off. When you mow, mulch cuttings to retain moisture.

Open Book and Board of Review

Questions regarding your property assessment can be made at the Open Book session at the Town Hall between 1:00-3:00 p.m. on May 15th to meet with Bowmar Appraisals. Open Book is a walk-in, informal discussion with our Town Assessor who will explain your property assessment and make possible adjustments.

What is Open Book?

It is a period of time that the records and assessor must be available to the people. Property owners can ask questions regarding how assessment was determined and to check that characteristics of the property are correct. Minor errors and misunderstandings can often be easily corrected at the Open Book session.

What if I don't agree with my assessment?

It is highly recommended to first meet with the assessor at the Open Book session before appealing to the Board of Review. If you still think the assessment is incorrect, first provide notice of intent to file an objection. Call the Town Clerk (729-0916) to get the form that MUST be completed at least 48 hours before the Board of Review. The Clerk will schedule a time for you to meet with the Board of Review. The Board of Review will meet on May 29th from 1:00-3:00

Spring Time is Crime Time!


The warmer weather also brings an increase in property crimes committed throughout Winnebago County. Property crimes have been the most reported incidents that have been victimizing our residents over the summer months. Of those property crimes, thefts, burglaries, and damage to property have been the most common.

Some interesting facts from the property crimes that were reported:

- A majority of the theft complaints were vehicles being entered either in parking lots or driveways.
- In the burglaries and thefts, almost half reported no force being used to gain entry.
- Most of the items taken from these incidents are those that can be easily removed, i.e., i-pods, cell phones, money, electronics, etc...

Common sense is our best defense and by following a few simple precautions it can help prevent any one of these crimes from occurring. Remember to always:

- Lock the doors and roll up the window tightly, even when running a quick errand
- Keep your purse, cell phone, and other valuables out of sight. Lock them in the trunk or take them with you.
- Do NOT leave personal identification or credit cards in your vehicle
- Mark expensive accessories with your driver's license number
- Never leave your keys in an unattended vehicle
- Park in a well lit area with pedestrian traffic
- If you have a garage, use it. Lock both the vehicles and the garage
- Be sure to remove automatic garage door openers from the car

~TOWN OF NEENAH REMINDERS~

*BURNING: Burning is permitted in the Town of Neenah, but the Fire Department requests that you use common sense (dryness and wind are always factors to consider), and that you call the Winnebago County Sheriff's office non-emergency number (236-7300#0) before and after burning to avoid false alarms. Please be considerate of your neighbors when burning, making sure the smoke isn't blowing in their direction. Burning garbage is prohibited.

*MINUTES AND AGENDAS:

Town minutes and agendas are posted on the Town website www.townofneenah.com and are also available at the Town Hall during regular business hours.

*ADDRESS SIGNS: Homeowners are responsible for maintaining the emergency address signs placed in front of their homes by the Town. Assure that the sign remains visible by keeping brush and snow away from the sign. Also, do not remove or relocate the sign.

*OBSTRUCTING RIGHTS-OF-WAY AND DRAINAGE DITCHES:

You cannot place a fence or greenery in the Town's road right-of-way. No part of a mailbox should extend over the paved portion of the road. In addition, culverts and drainage ditches must be kept clear of obstructions and must not be filled in. If you have a question about water drainage issues or the right-of-way, call Town Chairman Robert Schmeichel.

*BUILDING PERMITS: All building permits are issued by Building Inspector Gary Klinka (727-9200). Permits are needed to construct a fence or build a deck. If you aren't sure you need a permit, check with Gary.

*RECYCLING: All town recycling is picked up every-other-week, depending on where you live. All recyclables to be picked up must fit inside the container provided by Advanced Disposal. They will not pick up bagged or boxed items, or recyclables in other containers. Please do not wrap items with string

or place anything inside plastic bags. Electronics, waste oil, and other materials may not be placed with your recyclable or in the trash.

*DOG REMINDER: All Town of Neenah dogs must be licensed. The license is issued by the clerk/ treasurer. The cost for neutered/ spayed dogs is \$5, all others are \$10. Dogs cannot run at large. They must be confined to your property or on a leash and under your control if off the property. NOTE: Leashed dogs are allowed in the Town parks provided you immediately pick up any waste.

*Deer/Wildlife Problems:

The Town has no authority to handle wildlife problems. If you see a dead animal on the road call the County sheriff at 236-7300, ext. 8. If you have other wildlife problems, call a pest/wildlife control service.
