

**Town of Neenah Sanitary District No. 2**

**Resolution 2020-05**

**Increase of Sewer User Fee**

**WHEREAS**, the Town of Neenah Sanitary District No. 2 assesses a sewer user fee per RUC (residential unit charge) to maintain and operate the District; and

**WHEREAS**, the Town of Neenah Sanitary District No. 2 Board of Commissioners has not raised the sewer user fee per RUC since 2017; and

**WHEREAS**, the Town of Neenah Sanitary District No. 2 Board of Commissioners has reviewed the sewer user fee per RUC and compared the revenue stream to the District's expenses; and

**WHEREAS**, the Town of Neenah Sanitary District No. 2 Board of Commissioners may set sewer user fee rates as established by Wis. Stat. § 60.77(5)(e); and

**WHEREAS**, the Town of Neenah Sanitary District No. 2 Board of Commissioners recommends that the sewer user fee be increased by \$2.00 per month per RUC for an annual charge of \$528.00 per RUC; and

**WHEREAS**, the sewer user fee rate increase will be effective on January 1, 2021 upon its publication in accordance with Wis. Stat. §60.77(5s)(b);

**NOW, THEREFORE, BE IT RESOLVED** that the Town of Neenah Sanitary District No. 2 assesses a sewer user fee per RUC to maintain and operative the District; and

**BE IT FURTHER RESOLVED**, that the Town of Neenah Sanitary District No. 2 Board of Commissioners has not raised sewer user fees per RUC since 2017; and

**BE IT FUTHER RESOLVED**, that the Town of Neenah Sanitary District No. 2 Board of Commissioners has reviewed the sewer user fee and compared the revenue stream to District expenses; and


**BE IT FURTHER RESOLVED**, that the Town of Neenah Sanitary District No. 2 Board of Commissioners shall set the sewer user fee rate as established by Wis. Stat. § 60.77(5)(e); and

**BE IT FURTHER RESOLVED**, that the Town of Neenah Sanitary District No. 2 Board of Commissioners adopt the sewer user fee increase of \$2.00 per month per RUC for an annual charge of \$528.00 per RUC; and

**BE IT FUTHER RESOLVED**, that the Town of Neenah Sanitary District No. 2 Commissioners direct the Deputy Clerk-Treasurer to publish within thirty (30) days of the passage of this Resolution, a notice of the adoption of this Resolution.


