

## 2020, The Year of the Election Official

This year has been full of challenges. A typical year involving a presidential or governor election consists of four elections, but no one could have foreseen the challenges that faced us during this Election Year. The April Election brought a massive turnout of absentee voting that was not anticipated. The Town of Neenah sent out a request to our election officials to aid with the abundance of absentee requests, and they stepped up. The election officials worked long hours to aid the Clerk to ensure absentees were sent out in a timely fashion and ensure that all 1,333 absentee ballots were processed on Election Day.

When the August and November elections came, the election officials were ready and willing to help again. They helped the Clerk's office assemble the absentee ballots to ensure the first round of absentee ballots were mailed as soon as possible. They worked in shifts for the November in-person absentee voting and came in for additional training and Election Day preparation the weekend before the November Election.

## Be a Voice for the Town You Love

Do you like the idea of helping out your community with important decisions? Have you ever considered running for local government? If you answered yes to either of these questions, we have exciting news to share with you! The 2021 Spring Election is right around the corner, and local government positions are up for election.

The Town Board Chairman and two Town Board Supervisor positions are up for election this Spring. Incumbents are Chairman Bob Schmeichel, Supervisor Brooke Cardoza, and Supervisor Tom Wilde. These positions are two-year terms beginning on April 20, 2021. The Chairman receives an annual salary of \$14,760, and Supervisors receive an annual salary of \$7,380. Some of the interesting decisions and responsibilities that our government officials participate in are the annual Town budget, the Storm Water Utility District, and various committees.

One Sanitary District #2 Commissioner position is up for election. The incumbent

for the District is President Dan Osero. District Commissioner positions receive an annual salary of \$400. Some of the noteworthy decisions and responsibilities that the Commissioners participate in are the District budget, annual televising, and District projects.

If you are interested in serving on either the Town Board or the Sanitary District, you must declare your candidacy and file nomination papers to have your name appear on the ballot. The forms and a checklist are available in the Clerk's Office or at the Wisconsin Elections Commission website: [elections.wi.gov/candidates/local](https://elections.wi.gov/candidates/local).

The first day to circulate nomination papers is December 1, 2020. All completed forms, including nomination papers, must be delivered to the Clerk's Office by 5:00 pm on January 5, 2021. If a Primary Election is necessary, it will be held on February 16, 2021. The Spring Election is on April 6, 2021.

## AMENDMENT TO BOUNDARY AGREEMENT

On November 5, 2020, the Town of Neenah, the City of Neenah, and the Town of Neenah Sanitary District No. 2 reached an agreement to amend their existing boundary agreement to ensure that the Town's revenue from the Alliant power plant will continue for the foreseeable future. The amendment does this by "attaching" the power plant property to the City, thereby protecting it from annexation by other municipalities.

The separate Shared Services Agreement, also approved November 5th, arranges for the splitting of State shared revenue payments for the power plant between the Town and the City so that the Town is ensured the same revenue stream post-attachment that it received prior to the amendment, approximately \$250,000 annually.

Town Chairman Bob Schmeichel stated, "It was my determination to protect the Town of Neenah's boundaries and revenue stream, and that was accomplished seamlessly with the cooperation of the City of Neenah."

Because the Town and City were able to accomplish this arrangement by attaching the power plant property under the boundary agreement, there was no longer a need for the annexation that the Town had petitioned for. Therefore, the City dismissed the petition. As a result, no property other than the power plant was attached to the City.

## NEW BOUNDARY AGREEMENT

On October 26th, the Town Board approved a Cooperative Plan with the Town of Clayton, giving the Town of Neenah 25 years of protection from annexation in the event that Clayton incorporates into a village. A Boundary Agreement with the newly created village will not take effect until the date of incorporation, giving the Town of Neenah 25 years of protection from annexation into the new village.

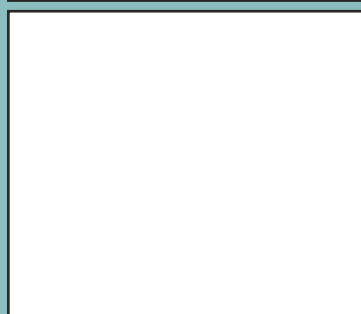
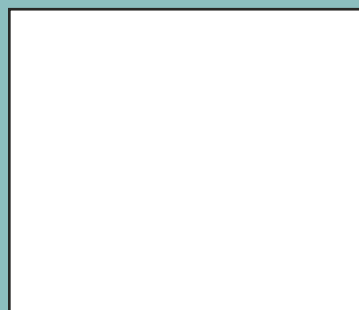

## SUPERVISOR'S SPOTLIGHT

Certainly 2020 has been quite a year. The pandemic has impacted all of us in many different ways and the Town was not immune to the impact. From the office trying to protect residents and staff during day to day operations and the elections to the Fire Department preparing, training and responding to fire calls and medical emergencies. The costs associated with these added protective measures and unanticipated activities were not planned in our 2020 budget.

The Federal government, and in turn State of Wisconsin, responded with two grant opportunities to help offset some of these unanticipated expenses

The grant from Wisconsin Elections Commission, WEC Cares Grant allocated \$2,909 to the Town based on the number of registered

voters as of June 2020. These funds were used to pay for additional staffing to manage the influx of absentee ballot requests for both the April and November 2020 Elections.

The Routes To Recovery grant from State of Wisconsin Department of Administration allocated \$58,836 to the Town for reimbursement of non-budgeted expenses resulting from the COVID19 response. The Town utilized these funds to purchase PPE for the Fire Department, the office and elections, cleaning supplies for the Town Hall and election space, added cleaning in the restrooms at the Town parks, additional postage and supplies for absentee voting and upgrades to computer technology.

The Town invested in computer equipment to update and secure our network and allow secure remote

access to work from home. The Town also invested in technology to set up the Town Board Conference room for remote meetings.

Since March, the Town Board has been meeting via Zoom, the Town Hall is open during these meetings with the Town Chair and Clerk in attendance for anyone interested in attending in person, but other Town Board members and members of the public are attending remotely for most meetings. With the technology upgrades and a "Zoom Room" set-up, the Town will be prepared to offer remote access to Town Board meetings well into the future.

### **AV OSERO**

This year Av Osero won her fourth consecutive championship in diving at the WIAA state competition. She became the fourth female diver in the history of Wisconsin High School to win four individual state titles and the second diver at the Division 1 level to have reached this achievement. She attained a score of 498.15 over 11 dives. Av Osero is a Town of Neenah resident and daughter of Dan and Lori Osero. She graduated from Neenah High School in 2020 and is pursuing a major in biology for pre-med.

### **JACK BRUCKS**

This year 10-year old Jack Brucks won the AMA Amateur National Championship in the 65cc stock class. He earned three first-place finishes and one second-place finish in a competition consisting of four races taking place over two locations. He also won the Youth Rider of the Year award that is given to the top-ranked racer in the nation from a specific age group and made an appearance on the Discovery Channel riding with Rick Ness. Jack Brucks is a Town of Neenah resident and son of Luke and Katie Brucks. Jack hopes to be a professional rider when he grows up.

## Storm Water Management

Storm water management is not something you think about until your ditch is not flowing properly, your basement floods or the roads are covered with water.

Similar to most of our neighboring communities, the Town collects an annual Storm Water Management Fee on your property tax bill. The fee remains unchanged for 2020 at \$100 per ERU. Residential properties are charged 1 ERU, undeveloped parcels are charged 1/2 ERU and business, commercial, and industrial parcels are charged accordingly based on their impervious surface.

The Storm water management fee is used to facilitate the management of storm water run off, in 2020 over \$1 million was spent on construction of the new CTH "O": pond which has already proven to be beneficial to drainage in the Town. The Town worked cooperatively with Winnebago County Highway Department and Village of Fox Crossing to benefit the area and share in the costs.

As a resident or business owner you can do your part to help with storm water management by keeping your ditches clean. Do not plow, shovel or blow snow into the ditch, do not add leaves, landscape material or other items to the ditch. A permit to work in the road right-of-way is required if you plan to perform any work in the ditch or right-of-way.

## CONGRATULATIONS, ELLEN SKERKE!

Congratulations to Town of Neenah's new Administrator-Clerk-Treasurer, Ellen Skerke. As of January 1, 2021, Ellen will become the Town of Neenah's first Administrator-Clerk-Treasurer. Ellen has served as the Clerk-Treasurer for the Town of Neenah since 2013. The Town Board of Supervisors unanimously approved for Ellen to become the Administrator-Clerk-Treasurer in a closed session in October 2020.

## WINTER HOME FIRE SAFETY

As outdoor temperatures begin to drop, it is never too late to be sure your house is ready for the winter weather. Fire Safety organizations and your utility providers recommend that you have your heating system checked, tested, and properly adjusted to handle the added demand colder temperatures bring. Furnace filters should be changed at least annually, especially before winter heating season, to avoid restricting warm airflow and forcing your furnace to work harder.

Check your hot water heating system. With older models, soot and corrosion can build up in the exhaust flue and lead to possible venting and potential carbon monoxide back-ups or leaks. The burners should be checked to ensure they produce the proper flame pattern for even heating. A good quality carbon monoxide detector should be placed in areas where your heating equipment is located and on every floor of your home close to bedroom areas. If your CO detector goes off and will not clear and you are unsure what the issue is, do not hesitate to call 911 to report the CO problem. A Town of Neenah Fire Department unit will respond with metering equipment to help identify the problem. Carbon Monoxide is deadly, and

alarms should not be taken lightly. Both Smoke Detectors and Carbon Monoxide detectors have a useful life of 10 years and should be replaced once they reach that age. Low/dead batteries can cause issues.

With the Christmas holidays fast approaching, please be careful with candles and any open flames in your home. Candles left unattended are one of the leading causes of residential home fires. Leaving home with a candle burning may have catastrophic results with a fire seriously damaging or destroying your home. All-natural Christmas trees pose a fire threat as the tree begins to dry out after being brought inside. The lower humidity in your home during the heating season will quickly pull moisture from the tree. Be sure to check the water level in the tree stand each day and add water as needed. An average size tree will use several gallons of water each week. Be sure your lighting decorations are in good repair. Newer LED lighting uses little energy and does not create the heat that older incandescent lights can.

## SANITARY DISTRICT #2

The Town of Neenah Sanitary District #2 met on September 24th and October 22nd for its 2021 Budget Workshops. During the budget workshops, the Commissioners discussed how new connections have slowed in Sanitary District #2, and they do not foresee any connections for 2021. The lack of new connections indicates that the District would be seeing a -1.76% change in operating revenue and an overall change of -11.31% in total revenue.

The District has many significant expenses that will be occurring in the near future. The Neenah Menasha Sewage Commission will be undertaking an expansion project to meet DNR requirements for phosphorous. Sanitary District #2 will be responsible for approximately 1% of the project's cost, equating to \$200,000. The joint project with the City of Neenah, the Collector Pipe Project, is finished. The District anticipates receipt of the billing for the project in 2021. Over the course of 2019 and 2020, the District completed a Lift Station 2 building to house a replacement generator, trailer, and updated control panels. Now, it is time for the District to replace the Lift Station 3 in-ground hut and generator with an above-ground structure, new generator, and control equipment.

After careful review and consideration of the budget's status, the Commissioners have decided to increase the sewer user fee by \$2 per month per RUC (residential unit charge). The annual sewer user fee per RUC for 2021 is \$528.00. The increase in sewer user fee will enable the District to have a 2.83% change in operating revenue and an overall change of -8.60% in total revenue. The Sanitary District #2's budget was approved on November 10, 2020, and found at the District's website: [townofneenah.com/sanitary-district-2/](http://townofneenah.com/sanitary-district-2/).

The Town Board met several times during the months of September and October to discuss the 2021 budgets of the Town of Neenah and Stormwater Utility District. On November 9th, the Town Board held a Public Hearing to review the budget and take questions/comments from the public on the proposed budget.

A Meeting of the Electors was also held on November 9th to pass a resolution approving the 2021 Town of Neenah Tax Levy in the amount of \$494,708. This is an increase of \$44,653 due to payments for debt service.

The 2021 Balanced Budget calls for total revenue and expenses to equal \$1,333,285. The 2021 budget in summary form, detailed form and a narrative of 2020 and 2021 activities can be found on the Town of Neenah website under Government / Town Budget.
