Spring Election 2021

The Spring 2021 Election will be held on Tuesday, April 6, 2021. All eligible voters in the Town of Neenah vote at the Municipal Building, 1600 Breezewood Lane, Neenah. Polls will open at 7 am and close at 8 pm.

There are many local positions on the Spring 2021 Election ballot. Sample ballots are posted on the Town of Neenah's website, Facebook page, and MyVote Wisconsin (www.myvote.wi.gov).

The Town Chairman and Town Supervisors each serve two-year terms.

<u>Town Chairman</u> Incumbent Robert Schmeichel is running unopposed.

Town Supervisors Incumbents Brooke Cardoza and Tom Wilde are running for two positions on the Town Board of Supervisors.

Sanitary District Commissioner

Sanitary District #2 has one commissioner spot up for election in its threemember commission. The elected positions serve six -year terms.

Dan Osero is running unopposed for Sanitary District #2.

The Town of Neenah joined the Joint Municipal Court in October 2020. You can find out more about the Town joining the municipal court in the Resident Handbook on the Town of Neenah website.

<u>Multi-Jurisdictional Judge</u> Jon Stelzner is running unopposed.

OPEN BOOK AND BOARD OF REVIEW

WHAT IS OPEN BOOK?

Open Book is a time for property owners to have a chance to meet with the Assessor to review their property record and assessment. Property owners can ask questions about how their assessment was determined or verify if the characteristics of the property are correct. Often times property owner concerns can be addressed during the Open Book process. Bowmar Appraisal is the Town Assessor and is available to owner questions during normal business hours at (920)733-5369 or *bowmar@sbcglobal.net*

WHAT IS BOARD OF REVIEW?

If a property owner is not able to resolve their concerns during Open Book they have the option of appealing their assessment to the Board of Review. A property owner must file a notice of intent to appeal with the Clerk at least 48 hours before the Board of Review is scheduled.

Typically Open Book and Board of Review occur in May each year. The schedule for Open Book and Board of Review will be posted on the Town of Neenah website under the Assessor tab, on the Town of Neenah Facebook page, and posting locations when the schedule becomes available.

ROAD CONSTRUCTION SEASON

As you all know, there are two seasons in Wisconsin. Winter and Road Construction Season!

Our first job in the spring is to do what we call the road tour. We look for roads that have deteriorated over the winter and confirm what roads we have budgeted to repair this year. Our town roads are rated on a 1-10 scale, with 1 being the worst and 10 being the best. Most of our town roads are in good shape, (the 6-8 range).

We are looking for general degradation of the road surface, potholes, cracks that have opened up, shoulder material that may be low, or the snowplow may have plowed it into the ditch. We are also looking for traffic and 911 signs that are down, or in poor condition. We are also observing road ditch drainage issues, debris in the ditch, as well as a plan to fix any problems.



A few of the methods we use for repair are wedging, crack sealing, chip sealing, and putting a thin overlay of blacktop over the top of the existing one. As a last resort, and the most costly, is a complete road reconstruction. This usually involves grinding up the existing blacktop, and using that as a base. We then put 4–5 inches of new asphalt over the top. Generally, a new road should last 25 – 40 years, but it has to be maintained over its entire life.

Last year, our major road projects were Fieldcrest Drive and Mandella Court. This year they are Acco Avenue and Carey Court. Our total Road Budget for 2021 is \$350,000, including new roads, repairs, signage, and snowplowing. Every time we have a snowstorm, the cost of clearing our roads takes money away from what we can spend on maintaining our roads.

So.... Let's hope we have seen our last snowstorm for this spring!

GOOD NEIGHBORS

When Wisconsin became a state in 1848, the Town of Neenah included the area now known as the City of Neenah, all the way up to Nicolet Boulevard. As the downtown area grew, it became a village, and then the City of Neenah in 1873. Because of the City of Menasha to the north and Lake Winnebago to the east, the only way it could grow was to the south and west into the Town of Neenah.

The Town of Neenah basically let the City grow at will until the 1980's when the DNR said the homes near Lake Winnebago needed to hook up to a municipal sewer system. The City, however, wanted these homes to annex to the City before hooking up. Eventually, the Town, after many legal battles, was able to get municipal sewer and keep that area in the Town.

The City, however, continued to grow to the south and west. As the leadership changed in the 1990's, the Town started to challenge every annexation. In 1999, as the City was ready to move south from County Road G to Muttart Road, the Town had had enough. With the Town people's approval, the Town purchased this property. As the legal battles continued, the Town purchased more land west of Tullar Road and north of Oakridge Road.

George Scherck was elected as mayor of the City of Neenah in 2002. Mayor Scherck said we all need to get along. Negotiations began to resolve our differences. In 2003 the Border Agreement was agreed to. As a result, the City has growth corridors it may annex from the Town without legal challenges. The Town has Town growth areas; in these

areas, the Town has access to the Neenah/Menasha Sewage plant via their sewer system. The agreement is for thirty years which we are eighteen years into. It will last twelve more years until 2033. The Border Agreement has stood the test of time.

The City of Neenah and the Town of Neenah are once again working together to make this a great area to live, work, and play.

OUR LOCAL PARKS, TREES AND FORESTS

Most of us probably remember a high school class where we talked about trees, edible plants, and other ecological issues. Most likely we have forgotten about most of that until our memory is jolted into an issue that is a little closer to our home. When I was younger, I remember many trees dying with "Dutch" Elm Disease." If you have been to Door County recently, you will notice Birch trees under assault and dying from Beech Bark Disease and Bronze Birch Borer.


That brings us to today and the Emerald Ash Borer (EAB). Nearly every nearby community is implementing a plan to attempt to slow the spread of the EAB and remove trees that have already died from the disease. The Town Park and Trails Committee has assessed the impact to our parks and trails and has started to implement our plan. We have had great support from our local DNR forestry division. The DNR has helped us confirm EAB presence and given regional guidance on mitigation and reforestation. Many trees at Conservancy park were infested with EAB that has caused the death of the trees. Chemical treatment has been ruled out as it is very expensive and has to be treated for each tree for the life of the tree. (The Ash tree can live 2–300 years!) Our Town of Neenah plan is as follows:

#1 Identify unsafe Ash trees near public spaces and remove them (Conservancy Park walking trail is a good example of trees removed that would have fallen onto the trail. This is being evaluated at all town parks.)

#2 Ash trees in other areas will be cut and left for nature or chipped into the woods.

#3 The DNR has given us electronic resources to plan for replanting and reforestation of our parks. The main theme (as with everything) is "diversification". If we replant many species of trees in the forest, it will be a strong forest and one disease will not wipe it out.

#4 State of Wisconsin grants are not available for the foreseeable future. Like Covid 19, no one expected the EAB financial drain on our budget.

Town of Neenah Fire Department is accepting applications for individuals who are interested in serving the community in the role of Paid-on-Call Firefighter. The Fire Department will provide all of the necessary training and protective equipment that you need to safely and effectively perform your duties. Each firefighter is compensated for training hours, emergency calls, staff meetings, and work details around the fire station. On average our firefighters will earn \$1,500 per year.

FIRE DEPARTMENT

Town of Neenah Fire Department is once again able to provide battery powered Smoke Detectors/Smoke Alarms to Town of Neenah residents

In 2017 the Town of Neenah Fire Department installed over seventy five (75) battery powered Smoke Detectors in single family homes throughout the Town. The Fire Department has secured additional units to be able to offer this service and important fire safety program once again. The smoke detectors/smoke alarms being provided are a sealed unit containing a lithium battery with a 10 year life, so no annual battery changes are required.

These Smoke Detectors have been provided to the Town of Fire Department at no cost under a grant program secured by the Professional Fire Fighters of Wisconsin. The goal of this program is to help reduce deaths and injuries from fires in single family homes. In 2020 there were 52 deaths in single family homes here in Wisconsin. So far this year in 2021 there have been 12 fatalities.

If your home was constructed before April of 1992, you more than likely have battery powered smoke alarms. Homes constructed after April of 1992 were required by state law to have hard wired smoke alarms installed during construction.

If you feel that the smoke alarms that you currently have installed in your home may not be in the best of shape or may be older, (the usable life of a smoke alarm is 10 years), or you do not have any smoke alarms in your home, the Town of Neenah Fire Department can help to provide and install new smoke alarms in your residence.

You will be contacted by a member of the Fire Department to arrange a time for the installation to take place.

In order to maintain safety during these installation visits, the Fire Department members performing



these installs will have had both COVID-19 vaccinations and will wear the appropriate PPE, namely face masks.

The Town of Neenah Fire Department looks forward to working with our residents to ensure their homes are as safe as possible.

STORMWATER, WHY DO WE CARE?

Stormwater runoff is rainfall that flows over the ground surface from buildings, driveways, roads, and other impervious surfaces.

It is important for stormwater management the ditches are kept clean and flowing. You are not permitted to perform any work in the road right of way without prior authorization from the Town of Neenah (except for mowing the ditch). Permits may be obtained from the Town Office. You may not reconfigure a ditch, add hardscape, landscape, or vegetative materials to the ditch, and you may not use the ditch to dispose of grass clippings, leaves, or other yard waste materials. Please do your part to keep the stormwater management system working properly.

The roadside ditches that collect the stormwater do not connect to a treatment system. Stormwater can pick up and carry litter, nutrients, bacteria, chemicals, sediment (soil), and other pollutants through a stormwater system, untreated, to the nearest creek, stream, or Lake Winnebago that we use for swimming, fishing, and as a drinking water supply. Stormwater pollution can impact aquatic life like ducks, fish, turtles, and birds. Polluted water can create a health hazard and affect drinking water sources.

- **PETS IN TOWN PARKS:** No animals or pets other than leashed dogs are allowed in Town parks. Dogs owners are required to immediately pick up and dispose of excrement on Town park property or adjacent to Town park property.
- **ROAD RIGHT-OF-WAY WORK:** Work in the Town road right-of-way (other than mowing) must be permitted through the Clerk's office prior to any work being performed. This includes placing rocks, stones, soil, debris, mowed grass in the ditch, or reconfiguring the town ditch.
- **BURNING:** Remember burning is permitted in the Town as set forth in Ordinance 5.05. Be respectful of your neighbors when burning. Contact Winnebago County Sheriff before and after burning (920)236-7300 #0 to avoid false alarms.
