## JOINT PUBLIC HEARING NOTICE

## CHAIRMAN'S CHATTER: BOUNDARY AGREEMENT

Hello, Town of Neenah. This addition of my Chairman's Chatter is primarily focused on our "Refreshed"

Back in 2003, the Town of Neenah and the City of Neenah entered into a mutual agreement document known as the "Boundary Agreement." This present agreement with the City of Neenah is a document that helps to protect the Town of Neenah boundaries for annexation to the City of Neenah through agreed upon areas of growth. Per state Statutes, Cities and Villages have annexation powers to annex properties out of the Town boundaries with very little opportunity for a town to object.

The Boundary Agreement is a document that helps protect the Town of Neenah boundaries by having agreed upon areas of growth, i.e., Town Growth & City Growth. All properties in the Town of Neenah have a designation assigned to

them: Town Growth, City Growth, Hybrid Areas, and a few other miscellaneous designations. The Boundary agreement with map of designated areas is available on the Town Website under Government and in the Clerk's Office.

The Town of Neenah, City of Neenah, and two Sanitary Districts (one of which has since dissolved) signed the original Boundary Agreement in April of 2003 with an expiration date of April 2033. Nineteen years later, the Town, City, and District determined it was in all of our best interests to revisit the terms of the agreement to discuss beneficial amendments.

As time progressed from 2003, so did the goals of both entities. And although the Boundary Agreement has worked well for the most part, the goals of both the Town and the City have evolved. To that, "Goals become the challenges to "Status Quo" and in part the term; "Lais'sez-faire" meaning letting things take their own course without interference. Achieving new goals, jointly by the Town and the City, given that the status quo has been

in place for an extended period of time, is and was nearly impossible. However, solid planning and negotiating for the greater good have prevailed, and an amended Boundary Agreement has come to fruition.

The proposed amendment to the current agreement provides for boundary line adjustments between the Town and City, adjustments to growth areas, provision for services, and extension of the termination date. The proposed amendment to the Boundary Agreement is available on the Town website and in the Clerk's Office. In recognition of their quick actions in May of 2021, the Town of Neenah Fire Department recently honored two individuals with a Life Saving Award.

Sophia Kubiak, a resident of the Town of Neenah, was instrumental in saving her father's life following a fall that resulted in him to stop breathing. Sophia is a 2019 Neenah High School graduate. She is in her second year attending Fox Valley Technical College to become a Licensed Practicing Nurse (LPN) and plans to further her education and career by earning a Bachelor's degree to become a Registered Nurse (RN)

Cyndi Pleshek, a Town of Neenah Fire Department First Responder and Town of Neenah resident, assisted Sophia and had a crucial role in saving Brian's life. Cyndi has been a First Responder with the Town of Neenah Fire Department for 22 years and was one of the first emergency responders to arrive at the Kubiak home following the 911 call.

Both Sophia and Cyndi were vital in saving the life of Sophia's dad, Brian. Sophia

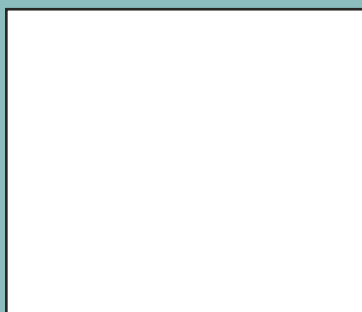

## SUPERVISOR'S SPOTLIGHT

Over the past few years, you most likely saw various articles or Television News reports covering the Fox Cities Exposition Center and the Champion Center. Since 2016 I've represented the Town of Neenah on the advisory committees for the Fox Cities Expo Center and Champion Sports Center. In addition, I represent the Town on the Fox Cities Room Tax Commission.

Located in downtown Appleton the Fox Cities Exhibition Center was dedicated in January of 2018. The 30,000 square feet connected by a sky bridge to the Paper Valley Hotel has combined event space for convention, trade shows, and corporate meeting space. The estimated economic impact to the Fox Cities is \$6 million annually.

The Champion Center, located on Champion Drive in Grand Chute, is a 164,000-sports venue featuring a year-round ice rink with seating for 1,000, a fieldhouse with four basketball courts or eight volleyball courts, and a seasonal arena. It is considered one of the premier sports tourism destinations in the Midwest. The Campion Center estimated economic

impact is over \$8 million annually.

So, you are asking how do facilities located in Appleton and Grand Chute help or impact the Town of Neenah? The \$14 million economic impact on the Fox Cities economy supports our local businesses as well as employment for our residents.

The most interesting point is that ten municipalities, including the Cities of Appleton, Neenah, Menasha, Kaukauna, Villages of Fox Crossing, Sherwood, Kimberly, Little Chute, Town of Grand Chute, and Town of Neenah collaborated and agreed to fund these venues through room tax revenues including hotel, Airbnb, and VRBO stays. All debt service on the Expo Center and Champion Center are paid with collected Room Tax revenue.

Both the Expo Center and Champion Center are truly assets to the Fox Cities communities.

was in her upstairs bedroom taking a virtual exam for her nursing program when her youngest sister,

Beatrice, ran in calling for her help because their Dad had fallen, was bleeding, and had stopped breathing.

Sophia immediately started CPR and asked her sister Estelle to call 911. Estelle communicated with the 911 dispatcher and held the phone for Sophia while the 911 dispatcher assisted by keeping count for the CPR compressions.

Cyndi lives in the neighborhood where this incident took place and was able to arrive on the scene very quickly, much to the relief of mom and wife Liz anxiously waiting at the front door for help to arrive. Cyndi was able to assess the situation quickly and take over until additional First Responders, and the ambulance arrived.

Due to the quick actions by Sophia and Cyndi, this story has a happy ending which the entire Kubiak family is grateful for and very thankful to everyone involved.

## FIRE DEPARTMENT FUND-RAISING EFFORTS

The Town of Neenah Fire Department is kicking off a fund-raising campaign in an effort to raise \$5,000 to 7,000 to upgrade the department's off-road Utility Vehicle. The department is looking to purchase a more robust, heavy duty, higher horsepower unit to aid in transporting water, firefighters, and equipment to off road grass and brush fires. The unit is also used in transporting medical personnel to locations that would not easily be accessed by an ambulance. A victim can also be transported out of remote areas using this vehicle and related equipment.

The need to reach out to the community for help with this project comes in part from the situation we all faced last year. Normally the department would sell raffle tickets for a Sportsman's raffle at its annual picnic. Last year the picnic was cancelled, and raffle ticket sales were put on hold during the height of the pandemic. Earlier this year, the department did not restart ticket sales as the situation was still very uncertain as the COVID 19 vaccine was rolled out. In the past, raffle ticket sales raised \$3,000 to \$4,000 each year, and projects like the one described above were able to be accomplished without significant difficulty.

## BURNING: COMMON SENSE GUIDELINES

As the days of summer slowly fade away, many of us may be doing a number of clean-up chores around the yard this fall. Some of those chores may involve the burning of yard debris. Here are some common sense guidelines to keep in mind:

- Never burn garbage, plastic, roofing materials, vinyl siding, tires, or other products that may contain petroleum products. All of these items are prohibited by the Wisconsin Department of Natural Resources and violate Clean Air Regulations.
- Avoid burning grass clippings. The smoke from grass clippings is normally very thick and will more than likely upset those living nearby. Leaf burning should also be avoided if possible, as leaves smolder for long periods of time, and the smoke can also cause concerns for your neighbors.
- Avoid creating large piles of materials to be burned and avoid burning after dark. Large fires can cause concerns to those residents that may see a fire in the distance, and during nighttime hours, fires are visible from greater distances. Keeping this in mind will avoid calls to 911 and having the Fire Department dispatched to investigate. If the fire is large enough and viewed as unsafe, the fire will be extinguished.
- Burn only when there is little or no wind. Any breeze can carry burning embers from a fire a significant distance and cause issues for other residents. Our guideline is that there should not be any burning when winds are greater than seven (7) miles per hour.
- Keep all fires, including recreational fires, away from all buildings, automobiles, boats, or camping equipment. Each year the Fire Department responds to larger fires caused when a small fire involves other materials that are close by.
- When you are burning, the fire must be attended at all times. Failure to attend to a fire is a violation of the Town's Burning Ordinance and will cause the fire to be extinguished by the Fire Department.
- Never use an accelerant to start a fire. Using a flammable liquid like gasoline can cause a fire to actually explode into flames and can cause serious injury to anyone starting a fire or others around you.

## CONSERVANCY PARK FALL BURNING

The prairie at the Conservancy Park will be burned this fall between mid-October and early November, whenever dry conditions allow. Controlled burning is an important tool in managing the prairie. Fire prevents brush and non-native grasses from overtaking the prairie, prevents build up of dead vegetation, which encourages weeds and retards new growth and improves the habitat for prairie birds, mammals, and butterflies. There is a substantial amount of Kentucky bluegrass in the southern two-thirds of the site, which threatens to overwhelm and compete with prairie plants reducing the abundance of native prairie plants and flowers. Suppressed wildflowers will not flower if there is not enough energy.

A fall burn works best in killing and/or reducing the amount of Kentucky bluegrass compared to a spring burn. Early spring burns do little to control Kentucky Bluegrass since it will not yet be emerged. In the fall, the bluegrass is at maximum height, making it more vulnerable to fire compared to the spring. Also, the prairie in the fall has more fuel since overwinter conditions knocked down prairie vegetation, and the forbs lose their leaves. A fall burn will burn much better, resulting in even more reduction of Kentucky bluegrass and other non-native cool-season grasses.

## FALL LEAF EFFECT

As fall settles in, the leaves begin turning fantastic colors, and we know that soon we will be reaching for our rakes. Fall leaf clean-up can be viewed as a fantastic workout or a time for kids of all ages to jump into colorful leaf piles. Unfortunately, in the world of stormwater and waterways, fall leaves can mean green algae.

There are a few options that you can do during fall leaf clean up to help keep our area lakes and rivers:

- \* Mulching leaves serves a dual purpose. The mulched leaves can be used to protect your plants in the winter, or finely mulched leaves can be left on the yard to provide some added nutrients for next spring.
- \* Composting. Leaves can be added to your compost to be used in your garden later.
- \* Raking and bagging. In the Town of Neenah, you have the option to rake and bag your leaves and dispose of them at the Winnebago County Landfill located at 100 West County Road Y, Oshkosh.

## HOW TO DRIVE A ROUNDABOUT

- ⇒ Slow down as you approach and navigate the roundabout.
  - ⇒ Watch for and obey the traffic signs.
  - ⇒ Yield to pedestrians and bicyclists as you enter and exit.
  - ⇒ Choose the correct lane before entering and yield to all lanes.
  - ⇒ Yield the right-of-way to trucks and other large vehicles per 2015 Wisconsin Act 139.
- Riding a bike in a roundabout:
- ⇒ If riding on the shoulder or bike lane, merge into the traffic lane by signaling before the shoulder/bike lane ends.
  - ⇒ Ride close to the middle of the lane to prevent cars from passing or cutting you off.
  - ⇒ Watch for cars entering the roundabout.
  - ⇒ If you do not want to ride your bike in the roundabout, use the sidewalk as a pedestrian.

## COUNTY ROAD CB & JJ INTERSECTION PROJECT

Winnebago County will be reconstructing the intersection of County Road CB and County Road JJ in the Town of Neenah and City of Neenah. The proposed improvement reconstruction will be a single lane roundabout and extension of Pendleton Road to connect to County Road JJ. The project is scheduled to begin utility relocations in the summer/fall of 2021, with construction slated for summer 2022. The intersection will be closed during construction, with detours posted for County Roads CB and JJ. Access to businesses and residents will be provided.
