Join us on Tuesday April 18, 2023 at 7:00 p.m. for the Town of Neenah Annual Meeting.

Your Town Officials that are elected on the April 4th Ballot will be sworn into office. The Annual Meeting is your meeting, a meeting of Town Residents.

The April Ballot has several items for your consideration including Wisconsin Supreme Court Justice, Circuit Court Judge Branch 2, Branch 6 and Multi-Jurisdictional Municipal Judge. Local races include Town Chairman, Town Supervisors, Sanitary District #2 and Neenah Joint School District Board. There are also three Statewide Referendum questions on the ballot. SUPERVISOR'S INSIGHT

Pollinators in Crisis, the Future is in our Hands

Our pollinators are in sharp decline. Native Wisconsin bee populations have decreased as much as 50%. The Rusty Bumble Bee once found across Wisconsin became the first federally listed endangered bumble bee and several other species of bumble bees are of special concern. Annually honey bee colonies are experiencing a 60% loss.

It is not just one factor that is causing the decline. Changes in habitat, diseases, invasive species, pesticides, and weather all can create the inhospitable condition for pollinators. Destruction of habitat is a huge concern. Miles of grass lawns with no flowering plants are detrimental to pollinators. Greater concentrations of pesticide products on lawns and gardens can cause immediate death to pollinators.

Global loss of pollinators is already causing over 500,000 deaths annually. Three quarters of crops require pollination. The inadequate pollination from loss of pollinators has caused a 3% to 5% loss of fruit, vegetable, and nut production.

We have been hearing of no mow May for a few years. Not mowing in May provides food for the pollinators when it may be scarce by allowing clover, common blue violet, and dandelions bloom. Dandelions also provide a benefit to the lawn. Their deep roots can help loosen hard packed soil. The taproot systems not only help aerate the soil but pull calcium and other nutrients from the ground and makes these nutrients available for nearby plants making dandelions a natural fertilizer. Another aspect of no mow May means not using pesticides and fertilizers during the month.

You can also help the pollinators by planting flowers in your yard. Some bee friendly perennials are stonecrop, milkweed, coneflower, goldenrod, asters, and yarrow. Many annuals such as alyssum, cleome, zinnias, sunflowers, salvia, calendula, cosmos and verbena provide blossoms all summer long. Culinary herbs such as sage, dill, basil, lavender, mint, and chives also provide food for pollinators.

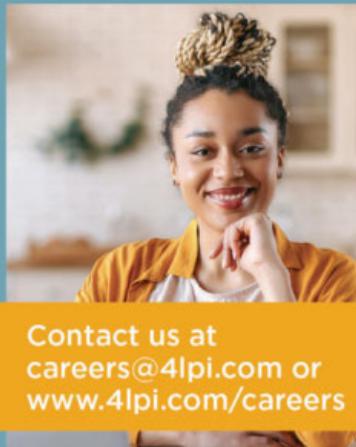

ELECTION INFORMATION

Spring 2023 Election— April 4, 2023 Polls open from 7:00 a.m. to 8:00 p.m.

Polling Location: 1600 Breezewood Lane, Neenah

Sample Ballots can be found on myvote.wi.gov, the Town website and Town posting board at the Town Hall

If you plan to vote by absentee ballot, visit myvote.wi.gov to request your absentee ballot. It is recommended that you request your ballot early and return your ballot quickly after receiving it. Absentee ballots must be received in the Clerk's Office by 8:00 p.m. on Election Day.

You may return your Absentee ballot in one of two ways:

- **Mail:** Return postage is provided with your Absentee ballot. USPS recommends mailing at least one week prior to Election day.
- **In-Person:** The person who voted the Absentee Ballot, may return it directly to the Clerk's office during regular office hours. Ballot drop boxes are not permitted.

When returning your absentee ballot, your certificate envelope must include:

- Voter Signature
- Witness Signature and Witness Address – complete with house number, street, city and state.

If any of these items are missing, the ballot can not be counted.

In-Person Absentee ballot requests can be made during regular office hours from March 21, 2023 to March 30, 2023.

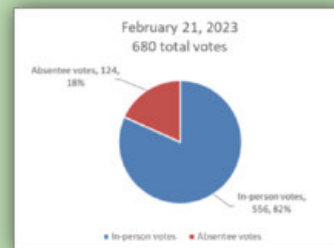
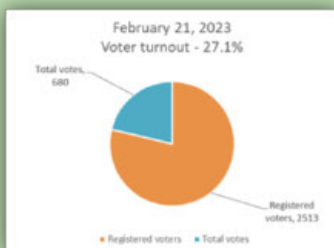

Election Deadlines and Dates

- ♦ **3/14/2023**—Clerk's Office sends out ballots to those that have an absentee application on file.
- ♦ **3/15/2023**—Deadline to register to vote online, after this date, voters must come to the Clerk's Office to register to vote or register on Election Day
- ♦ **3/30/2023** - Deadline to request an absentee ballot be mailed to you. It is advised that you make your request in advance of this deadline to provide sufficient time to receive and return your Absentee Ballot .
- ♦ **3/31/2023** - Deadline to register to vote in the Clerks' office, after this date, voters must register at the polls on election day
- ♦ **4/4/2023**—Spring Election Day

FEBRUARY 21, 2023 – ELECTION TURNOUT



The Town of Neenah participation in the recent election for the Wisconsin Supreme Court is summarized in the above charts. 680 total votes were recorded of the 2,513 registered voters resulting in a 27.1% turnout. PARKS AND TRAILS COMMITTEE



YOU BREAK IT, YOU BUY IT!

The Town of Neenah Park and Trails Committee has been busy during the season when most of our parks are winterized during the cold weather. We have been addressing many ways we can continue to bring the Town of Neenah Taxpayers a great Park and Trail experience. We continue to improve our facilities, natural areas, and provide a safe place to relax and enjoy.

One issue that has continued to increase in many communities is vandalism. Each year we are using more of your taxpayer dollars to repair or replace broken

items. Vandalism is occurring on two separate levels. The first is intentional damage to property. This can be damage from persons, vehicles, graffiti, or intentionally breaking or stealing town property. We will continue to identify and prosecute the offenders. Surveillance is a great tool, but nothing replaces your eyes, physical presence, and willingness to call the sheriff immediately for suspicious activity. Vandals dislike it when others are around for fear of being caught.

The second type of vandalism is unintentional. This can be as simple as having a dog off leash, doing their business in recreational areas, or people using the park for unintended purposes. A good rule to follow is "If you wouldn't do it in your yard, don't do it in ours".

Did you know that a golf ball or other objects lost in the grass come out of a commercial lawn mower at speeds of over 170 miles per hour and will fly over 50 feet at this speed? (A professional golfer's swing is 168 miles per hour. This carries as much initial force as a .357 bullet).

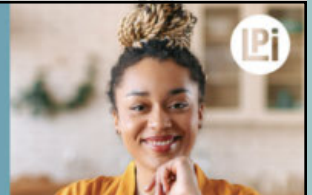

Town of Neenah Fire Department hard at work for Town Residents, Business Owners and Property Owners.



The Town of Neenah Fire Department recently completed a Public Protection Classification (PPC) survey with the Insurance Services office (ISO). Fire Chief Chad Dolphin and our Fire Fighters worked with the ISO Office as they completed their survey and completed their analysis of the Town of Neenah's ability to fight structure fires. The Insurance Services office completed their analysis of the information gathered in order to review the Town's classification.

Effective May 1, 2023. The Town of Neenah's Public Protection Classification will be upgraded to 4, it had previously been 5.

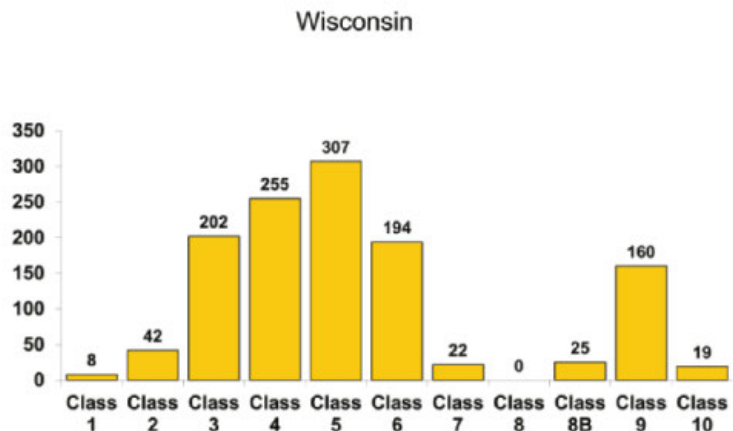
What is an ISO rating and why might this be important to you? An ISO Fire Rating is a score provided to fire departments and insurance companies across the country by the ISO. The score reflects a community's preparedness to fight fires. The score primarily focuses on TNFD's training and readiness to fight fire and the available water supply, there are other factors that contribute to the score. The highest PPC score that a fire department can receive is a 1, and the lowest score is a 10. The chart below shows the ranking of fire departments across the State of Wisconsin.

Many U.S. insurance companies use the PPC ranking when making decisions affecting the underwriting and pricing of homeowners insurance. You may have an opportunity to lower your homeowners insurance premiums with the new ranking that becomes effective May 1, 2023. EMERGENCY ADDRESS SIGNS



The brown address signs, sometimes called 911 address signs or uniform address signs are critical for emergency responders to locate your address as quickly as possible.

Spring is right around the corner, snow will soon be melted. This is a good time to check your sign, make sure your sign is straight, no tall grasses or brush is grown up near it and it is easily visible to the Sheriff Department, Fire Department, Ambulance driver or anyone else needing to find your house or business.

It is the property owner's responsibility to maintain the sign, ensure it is visible from both directions on the road and has not been moved, altered or removed.

Town Officials have recently noticed that many of the signs are yellowing and perhaps less reflective than when first installed. After checking in with the manufacturer, it is believed to be caused by hard water from sprinkler systems. The signs can be cleaned fairly easily with

a product such as "Rust-Out" If you notice that your 911 address sign is not quite as white as it used to be, please try cleaning it.

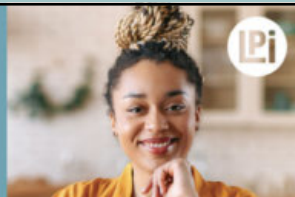
If your sign is damaged or illegible, contact the [Town Clerk](#) to arrange for a replacement sign. There is a fee for a replacement sign.

IMPORTANT ANNOUNCEMENTS!



In anticipation of the new Neenah High School opening in the Fall of 2023, the speed limit on Larsen Road has been reduced to 35 mph. The road was modified in 2022 to add turn lanes to accommodate Rocket Way. In the summer of 2023, traffic signal lights will be installed at the intersection of Larsen Road and Rocket Way. The Town is in the design phase for reconstruction of Larsen Road.

The ditches in front of your property are in the Town road right-of-way and are a part of the overall Town stormwater management system. It is a violation of Town of Neenah Municipal Code 13.06 to change the configuration of or add anything to the ditch including snow, grass, vegetation or landscape materials. Property owners must obtain a permit from the Town Office prior to performing work of any kind in a road right-of-way ditch. This includes temporary use of the ditch for construction projects of any kind. Permit Fee is \$25.00.

DOG LICENSING



Annual Pet licenses are required for all dogs over 5 months of age. A valid rabies certificate is required for a pet license to be issued. Dog Licenses expire each year on December 31st and should be renewed before April 1, 2023 to avoid paying a \$5 late fee. Licensing can be done in person at the Town Hall or by US mail (please include a self-addressed stamped envelope). License fees are \$5.00 for spayed/neutered dogs and \$10.00 for unaltered dogs.

• **WEIGHT LIMITS:** Weight limits on Town Roads to begin in mid March. Notice will be posted to the website. Weight Limits remain in effect until weather and road condition permit. Contact the Town Office with any questions: (920)725-0916

• **YARD SIGNS:** Yard signs are NOT permitted in any Town Road right-of-way, including advertisements and political signs.

• **ROAD RIGHT-OF-WAY WORK:** Work in the Town road right-of-way (other than mowing) must be permitted through the Clerk's office prior to any work being performed.
