

CHAIRMAN'S CHATTER

Hello Town of Neenah,

Here we are once again near the end of summer and the beginning of fall. And as the warm breeze turns into a crisp chill, the beach or pool days dwindle, and the dawn of fall rolls around — saying goodbye to hopefully a well-spent summer may be difficult. However, this year's summer may have brought you some cherished memories, wonderful travels, a chance to relax and, of course, a great tan. It's best to celebrate and look back on those moments with gratitude and look forward to the remainder of the year. August can be both a last chance to lay back and relax and/or getting ready for the upcoming hectic school year. Whereas September is a thirty-day long goodbye to summer, to the season that left everybody both happy and weary of the warm/hot, humid weather. None the less here we come...and what should we be looking forward to and expect here in the Town?

With the coming of the new school year in which the Neenah Joint School District has made major changes and improvements, safety is an important issue. Traffic patterns will change and increase both at the new location of the middle school facilities on Tullar Road and especially at the new high school location, Rocket Way, located between County Road II and Larsen Road. As most, if not all of us know, the roadway condition of Larsen Road at present time is not good. As has been reported here, the Town has plans to reconstruct the roadway which includes a

trail way route. However, that construction process will not be completed until the 2025 construction year. We all have to exercise caution while traveling this route whether it is going to or coming from work or school. The speed limit on Larsen Road in the Town of Neenah has been reduced to 35MPH and will be monitored by Winnebago County Sheriff's Department. The Town will not allow this road to become a "Rocket" way to and from your destination! Also, it should be noted that the main roadway entrance to the new high school is County Road II on the north side of the school properties. Given the new road markings on Larsen Road and at the "T" intersection at Rocket Way and Larsen Road there no doubt will be daily traffic using that entrance way. There presently is a set of temporary stop & go lights at the "T" intersection of Larsen Road and Rocket Way. Once the reconstruction of Larsen Road has been completed, the traffic light will become a permanent installation. Please be observant and use caution when approaching that intersection. Also, except for extreme emergency events, Michaels Ave. on the west side of the school property, IS NOT an entrance nor exit from Rocket

Way. This is a designated Town of Neenah Dead End road. Please be respectful of the neighborhood privacy.

Speaking of roads. Our 2022 ending budget for Public Works, i.e., roads and maintenance thereof, was \$822,094. This was 42% of our total annual 2022 budget. Our 2023 project budget as given in our annual report is \$786,405 which is 45.4% of our 2023 budget. The General Transportation Aid that is allocated from the State is and has been \$2,734 per road mile. Our Legislature sent a bill to the Governor this legislative year that increased the "GTA" monies by 2% in each year of the biennium. The Governor vetoed the per road mile rate increases and thus the rate will be stuck at \$2,734 for 2024 and 2025. This is not "Political Editorial", however, at that rate and given that the Town has 27 credited miles of roadway, that equates to under \$80,000 of much needed road aid funds to maintain our roads.

So, when residents ask why we did a planned road maintenance to what seems to be an okay road or, when are we going to fix this or that road, I and your Town Board say that we are doing the best we can with what road \$\$\$'s we have budgeted. And that is why we Chip Seal roads to prolong their "life" before the roadways become too deteriorated and have to be reconstructed at a high price tag. It is called "BMP", Best Maintenance Practices. It is a challenge!

On a positive note, two (2) major Town projects will be coming to fruition this calendar year and they are:

- 1.) Mahler Park parking lot; repaving and stripping and relocating/installation of some of the overhead pole lighting. Mahler Park actually counts in our credited "road miles". Take a slow ride through and stop and enjoy your park. and,

- 2.) The renovation of our Town Hall to include a larger main meeting assembly area, storage space, expanded kitchen facilities, and updated HVAC

system. The Town Hall parking lot will also be repaved and stripped. This project is a result of Town of Neenah's \$369,166 ARPA funds and will utilize a portion of the ARPA funds.

And, as long as we're talking about budgets, Town budgets to be exact. Your Town Board holds their annual budget workshops every September and October to set the next year's budget. The 2023 budget workshops for the 2024 budget year are: September 14th, September 28th, and October 19th. All are at 4:00pm and all are open to the public and all Town residents are welcome to attend.

Okay! Now, my Fun Fact, newsletter addition. With the onset of the school year did you know that the first kindergarten classes in the U.S. were held in Watertown Wisconsin in 1856. Ah yes, fond memories. Mine was a "Mother Goose" play at the end of the year. I was dressed as Peter Peter the Pumpkin Eater.

Wisconsin is known for its great state camp sites. Here is some "Campfire Trivia" conversation: What do ice cream sundaes, garbage disposals, malted milk, the Supercomputer, and typewriters have in common?..... They were all invented in Wisconsin, of course!

And lastly, what is the oldest city in Wisconsin?.... Located along the banks of the Fox River, Green Bay is the oldest settlement in Wisconsin. Early French voyageur, Jean Nicolet, knew about the site and named it Baye des Puants which translates to.... "the Bay of the Stinks"!!

SUPERVISOR'S INSIGHT

The Roads We Drive on Every Day

There are 28 miles of roads in the Town of Neenah. If you live in the Town of Neenah (and most of you do) you travel daily on different designated roads. Roads have different jurisdictions that you may not realize. There are State Highways, County Roads, Town Roads, and Private Roads. Each road is managed differently and require different funding sources.

County Roads

The ongoing maintenance and snow removal on county roads is managed by Winnebago County and shows up on your taxes. Road maintenance and snow removal is managed by the Winnebago County Highway Department.

Town Roads

Town roads are managed by the Town's Road Superintendent and are evaluated annually to assess the condition of the roads to determine roads that need attention. Bi-annually, a PASER rating (Pavement Surface Rating System) is submitted to the State of Wisconsin. The PASER report is a ten-point rating system that helps to identify problem areas and those roads which will need repairs in the future. The most recent PASER report for the Town roads is available at the Town Hall for review and available at www.townofneenah.com. Snow removal on Town roads is outsourced to Winnebago County Highway Department and all maintenance is paid by Town of Neenah taxes.

Private Roads

When strong winds fall a tree on a private road in the Town of Neenah (Rainbow Beach Road, Plummers Harbor Road, Popular Court, Adella Beach Road, Rickers Bay Road, a portion of Armstrong Street and Wildlife Lane), the owners on the road are responsible to contract (at their expense) with a service or do it themselves. Same is true with snow plowing. Houses or landowners on private roads are responsible for most of their own road work, such as snow plowing and road repair/replacement. If they want a professional to do the work, they must hire someone with their own money to do it. This expenses are not paid by your Town of Neenah taxes.

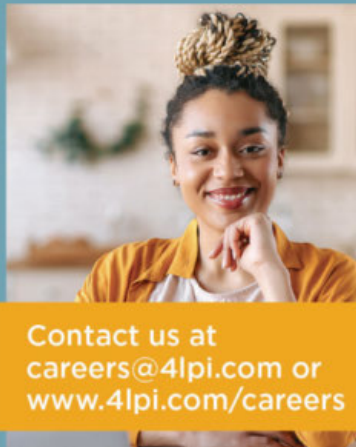

PARKS AND TRAILS COMMITTEE

In this newsletter I would like to feature a unique park right here in the Town of Neenah!

Conservancy Park is located on the corner of County A and South Park Avenue.

It serves many purposes. It takes a large quantity of surface water and slows it down so that pollutants and chemicals can settle out before going into Lake Winnebago. We placed decorative fountains to help aerate the water for wildlife and to assist in clearing sediment. Because these fountains are electric, fishing is not allowed in the park. Fishing line gets tangled in the motors and is very costly to repair. We have also designated areas for wildlife only, because we have nesting geese, ducks, turtles and a Blue Heron that continues to visit us each year. There are storyboards that tell about the prairie and the ponds.

A senior Ecologist that developed and helps maintain the prairie has stated that this is one of only a few diverse prairies in the state and is a premier site for many species of plants, grasses and wildflowers. There is an ADA accessible paved path and picnic tables for everyone to enjoy.

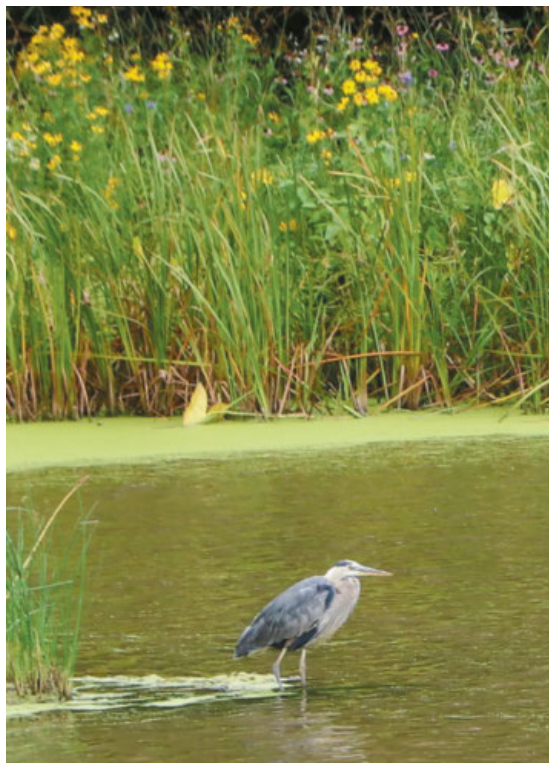

We have started a rough cut of a woodland trail that will be completed in the spring of 2024. (We ask that you please wait for it to be completed before using it). It will be a rough grade terrain and available for seasonal use. It will be great for snowshoeing, cross country skiing, and walking. Due to its rough and natural state, in the spring and summer there will be times it will be muddy and have mosquitos to greet you. It is intended to stay natural, with some natural benches along the way. It will also be the start of our reforestation project to diversify our trees in the forested area. (I will save that for my next newsletter article).

We will be replacing the kiosk in 2023 for a more enjoyable and welcoming entry to the walking path. Please get out, enjoy the diverse plants and wildlife, take pictures and enjoy this hidden gem in YOUR Town of Neenah!

TOWN OF NEENAH SANITARY DISTRICT #2

Great news!

Our lift station #3 project is completed, and it is operational. During the August 3, 2023 power outage both main lift station (#2 & #3) generators started immediately upon power loss and stayed on line until power was restored. Lift stations #2 & #3 are our main lift stations which can't go down because they receive sewage from our other seven lift stations before sending it on to the City of Neenah sewage system. These main lift stations are powered by three phase power and require dedicated generators for backup power. Our other seven lift stations are powered by single phase power, and we have a portable trailer mounted generator that can power them in the case of a power outage. The generators, pumps, and other equipment must be operational at all times to ensure sewage flow in the desired direction (toward the treatment plant).

To make sure our equipment is constantly operational the TNSD2 commissioners and staff meet several times a year to research and set an operating budget. Our incoming revenues are from user charges, connection fees, permit

fees, and interest. These revenues must meet the expenses which include the conveyance and treatment of the sewage, power to run the lift stations, maintenance of the lines and laterals (televising), replacement of and/or repair of pumps and generators, administrative services (Diggers Hotline), and others.

Our user fee has remained the same for several years due to our effective partnership with Midwest Contract Operations, and McMahon Engineering. We must be vigilant about taking care of our "Out-of-Sight" equipment by not flushing ANYTHING but human waste and toilet paper. We have encountered repair bills for pumps that were strangled by "Flushable wipes" (see photo). Even facial tissue can clog sewage pumps. We all want our sanitary system to operate properly for years to come.

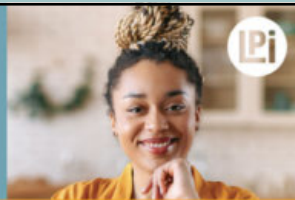

Fall leaves provide beautiful color on trees, but in local waters, they contribute to algae blooms—not pretty!

Options to deal with leaves so they don't impair the health of waterways include:

1. **Mulching** - you can mow over leaves & leave them on the land

3. **Raking & Collecting** - be sure to follow community collection policies and cover leaves with a tarp between pick-up times
