Join us for the swearing in of your Town Officials elected on the April 2 ballot. This Annual Meeting is your meeting of Town Residents and is also an opportunity to see the changes made at your Town Hall.

In fact, you remain four times more likely of being hit by a vehicle at nighttime without some sort of reflective clothing. Let's be safe out there. If you plan to vote by absentee ballot, visit myvote.wi.gov to request an absentee ballot. It is recommended that you request your ballot early and return your ballot quickly after receiving it. Absentee ballots must be received in the Clerk's Office by 8:00 p.m. on Election Day.

When returning your absentee ballot, your certificate envelope must include:

- **Voter Signature**
- Witness Signature and Witness Address complete with house number, street name and city.

If any of these items are missing, the ballot will be returned to the voter.

Visit <u>myvote.wi.qov</u> to register to vote, see what's on your ballot, request an absentee ballot and track your ballot.

Winnebago County Revolving Loan Fund for Growth in our Community

Are you a business owner in Winnebago County looking to grow? Need additional funds to help expand your business? In collaboration with Winnebago County, Greater Oshkosh Economic Development Corporation has introduced the Winnebago County Revolving Loan Fund with the goal of supporting local businesses in Winnebago County. Greater Oshkosh Economic Development Corporation was established in 2015 as a private-public non-profit economic development corporation. According to their website, greateroshkosh.com, Greater Oshkosh EDC "...exists to preserve the health of existing companies, foster a positive entrepreneurial environment, connect companies to workforce and talent development resources, enhance the business climate and promote the quality of life in the greater Oshkosh area."

The loan program is designed to provide existing businesses in Winnebago County with capital they may need for growth and expansion. They will match \$1 for every \$1 of traditional capital investment sources within a range of \$25,000 to \$205,000.

The fund supports a wide range of business needs including the acquisition of land and buildings,

inventory, site preparation, construction, rehabilitation, fixed equipment installation, intellectual property, clearance or demolition, working capital, research and development, employee training, marketing for new products or entry into a new niche, employee recruitment and transfer, and interest rate buy-down with private sector lenders.



Greater Oshkosh EDC has established an easy loan process including 1. Schedule a meeting 2. Complete the application 3. Get approval 4. Sign agreement and 5. Grow your business! Loan terms, interest rates, repayment and collateral will be determined on a cause-by-case basis. Qualified enterprises must operate within the corporate limits of Winnebago County and have at least two years of financial history.

In addition to the Winnebago County Revolving Loan Fund, Greater Oshkosh EDC offers other capital programs including Greater Oshkosh Capital Catalyst Fund, Greater Oshkosh Revolving Loan Fund and the Rural Winnebago Revolving Loan Fund. Making these funds available to business owners in Winnebago County, including residents in the Town of Neenah, helps to create opportunities and growth in our community. DOG LICENSING REQUIRED

The State of Wisconsin requires that all dogs receive rabies vaccinations by a veterinarian, and are licensed annually by their local municipality.

The licensing year for dogs is January 1—December 31, and licenses for 2024 were available for 2024 beginning the first week in December 2023.

Be sure to bring a copy of your rabies certificate to the Town Hall when registering your furry friend (a copy is not kept on file). The Town requires licenses for dogs over 5 months of age, and new residents must license their dog within 30 days.



How to obtain a license:

By mail:

Include a completed application (found on our website under Resources), rabies vaccination certificate, proof of sterilization, the appropriate payment and a self-addressed stamped envelope. Once your application has been processed, the certificate and new license will be mailed back to you.

At the Town Office:

Bring in the rabies vaccination certificate, proof of sterilization and the appropriate payment.

License fees:

Spayed or Neutered: \$5.00; Not spayed or Neutered: \$10.00

Note: Any license purchased after March 31 (except for new dogs) will be accessed a \$5.00 late fee.

PREVENT RECYCLING FIRES BY SAFELY DISPOSING OF USED BATTERIES

Sitting under the stars by a crackling fire has its appeal. It's where stories are told, sing-a-longs happen, and meals are cooked over an open flame. Campfires bring family and friends together. But campfire mishaps can cause injuries. With a few safety tips, you can prevent these accidents.

SAFETY AROUND THE FIRE

- Before setting up a campfire, be sure it is permitted. Check with your local fire department.
- If campfires are permitted, they need to be at least 25 feet away from any structure and anything that can burn.
- Clear away dry leaves and sticks, overhanging low branches and shrubs.
- Avoid burning on windy, dry days. It is easier for open burning to spread out of control when it is windy and dry.
- Watch children while the fire is burning. Never let children or pets play or stand too close to the fire.
- Attend to the campfire at all times. A campfire left alone for only a few minutes can grow into a damaging fire.
- Keep a campfire small which is easier to control.
- Never use gasoline or other flammable or combustible liquids.
- Always have a hose, bucket of water, or shovel and dirt or sand nearby to put out the fire. Make sure to put it completely out before leaving the site.
- If your clothes catch fire, stop, drop, and roll. Stop, drop to the ground and cover your face with your hands. Roll over and over or back and forth until the fire is out.
- Treat a burn right away. Cool the burn with cool water for 3 to 5 minutes. Cover with a clean, dry cloth. Get medical help if needed.



If roasting marshmallows, help young children. Never shake a roasting marshmallow. It can turn into a flying, flaming ball. A heated metal skewer can cause burns.

Protecting our Water-ways - You can Make a difference

- Did you know that storm drains are not connected to the sanitary sewer systems and treatment plants? Whatever enters the catch basins in our parking lots and roads goes untreated into our creeks, streams, rivers and lakes!
- Did you know that grass clippings contain phosphorus, the nutrient that turns lakes green with algae! One bushel of fresh grass clippings can contain 0.1 lbs of phosphorus-enough to produce 30-50 pounds of algae growth if it finds its way to a lake or river!
- Did you know that nutrients and fertilizers can actually pollute our waterways, causing the green algae growth we see in many of our rivers and lakes?
- Did you know that excess lawn watering, especially over fertilized lawns causes polluted water to drain into our storm drains and out into our fresh water?
- Did you know it has been estimated that an average acre of a well maintained urban lawn receives an annual input of five to seven pounds of pesticides. Some of that pesticide gets washed away by rain or lawn watering into the street and into storm drains.

Grass Clippings, fertilizers and pesticides are entering our water-ways, polluting our rivers and lakes, and harming our wildlife.

You can make a difference

Proper Lawn care will make a difference in protecting our waters and wildlife, and save you money and time.

- ⇒ Leave grass clippings on the lawn
 - ♦ Leaving grass clippings in place leaves the equivalent of I pound of nitrogen per 1,000 sq ft - the same amount you would get from 1 fertilizer application.
- ⇒ Set the lawn mower at a higher setting (over 2.5 inches) letting shorter blades fall back onto the lawn as natural fertilizer. Sharpen mower blades every I 3 years
 - ♦ Lawns mowed higher are more competitive against weeds.
 - Lawns mowed higher withstand heat stress better, need less watering, and are more resilient, reducing bare spots and soil erosion.
 - Lawns maintained at higher heights usually develop deeper roots and dry out slower
- ⇒ Mow when your lawn needs it, not on a fixed schedule
- ⇒ Water your lawn only when needed, not on a fixed schedule
 - Use a rain gauge to measure rainfall and watering
 - Use a sprinkler that shoots low to the ground oscillating sprinklers often loose water to evaporation
 - Determine your lawn's watering needs if grass in a foot- print does not spring back, watering is needed
- ⇒ Practice hand-weeding
- ⇒ Use mulches to reduce weeds
- ⇒ Spot treat weed and insect areas
- ⇒ Evaluate if a pesticide is necessary
- ⇒ Learn to live with a few weeds!



- YARD SIGNS: Yard signs are NOT permitted in any Town Road right-of-way, including advertisements and political signs.
- PETS IN TOWN PARKS: No animals or pets other than leashed dogs are allowed in Town parks. Dogs owners are required to immediately pick up and dispose of excrement on Town park property or adjacent to Town park property.
- ROAD RIGHT-OF-WAY WORK: Work in the Town road right-of-way (other than mowing) must be permitted through the Clerk's office prior to any work being performed.
- BURNING: Remember burning is permitted in the Town as set forth in Ordinance 5.05.
 Be respectful of your neighbors when burning. Contact Winnebago County Sheriff before and after burning (920)236-7300 #0 to avoid false alarms.
