R. Schmeichel called the meeting to order at 7:00 pm. Pledge of Allegiance was recited.

#### **Public Forum**

Cheri Long, candidate for Neenah Joint School District School Board introduced herself and gave
a background of her reasons for running for the School Board and her goals if elected. Her
passion lies in adding a dyslexia curriculum and getting back to basics to improve reading
comprehension.

### Public Forum for Recognized Municipal and County Officials

 Winnebago County Sherrif Deputy Noftke introduced himself. The Board had no questions or comments at this time.

#### Yard Waste Collection

Discussion regarding potential yard waste services, burning and other nuisance issues, and tax levy restrictions.

- R. Schmeichel discussed the upcoming Annual Meeting, the newsletter and potential conversation about burning and yard waste collection.
  - It is an increasing concern every year with the nuisance of burning, some residents like it, others do not. If the Town were to consider burning restrictions, they need to consider how yard waste could be managed.

- A local landscape business approached the Town with a plan for leaf collection in the fall and optional brush collection.
- If the Board were to consider burning restrictions, for who, would agriculture properties be permitted to burn
- R. Schmeichel discussed the Town tax levy, it has not increased since 2011 due to the levy limit restrictions. The only possibility to raise the levy limit is through a referendum.

General discussion about leaf collection potential

- D. Bluma is in favor of considering leaf collection services if the Town bans burning.
- J. Weiss is concerned with leaves being raked into the drainage swale and slowing down drainage
- B. Cardoza stated the Town would be relying on one company and how would new manage the service if this company did not work out
- T. Wilde is concerned with leaves clogging the culverts if raked into the drainage ditch and not picked up soon enough or if rainy weather delays the service.
- By general consensus, the Board would like additional information from the business owner to discuss a potential plan.
- By general consensus, all of these subjects including tax levy are long-term conversation with residents to get their input. There needs to be advertising of these subjects in advance of the Annual meeting and invite input form the residents.

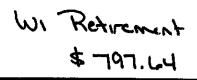
