ORDINANCE AMENDING CHAPTER 4, TRAFFIC CODE, TOWN OF NEENAH CODE OF ORDINANCES

The Town Board of the Town of Neenah, with quorum present and voting, hereby ordains the following amendments to Chapter 4, Traffic Code, Section 4.04 Parking, Stopping and Standing of the Town of Neenah Code of Ordinances:

4.04 PARKING, STOPPING, AND STANDING is amended to read:

- (1) Overnight Parking. Unless authorized by the Town Roads Superintendent or Town Chairman, no person shall park any vehicle including automobile, truck, trailer, truck power unit, bus recreational vehicle and/or combination of vehicles, between 12:00 am 7:00 am on any Town road, including the road surface, road right-of-way, ditch and shoulder.
- (2) Trailer parking. Unless authorized by the Town Roads Superintendent, or Town Chairman, no person shall stop, stand, or park any trailer unattached to a vehicle on any Town road, including road surface, road right-of-way, ditch, or shoulder, except to stop temporarily for the purpose of and while actually engaged in loading or unloading the vehicle or trailer.
- (3) Parking heavy vehicles in residential districts. No operators of a motor truck, truck-tractor, trailer, or semi-trailer or any other commercial vehicle or combination of commercial vehicles shall park such vehicle on any Town road, including the road surface, road right-of-way, ditch and shoulder, except for such time as is reasonably necessary to facilitate the loading or unloading of the vehicle.
- (4) Contingent upon the erection of proper signing, no parking is permitted on the following Town of Neenah roads, except emergency parking:
 - (a) Any roadway within a Town of Neenah park in excess of the length of time or between the hours specified by the Board. See Subsection 15.02(9) herein.
 - (b) Green Valley Road between the south driveway of Greenlawn Memorial Cemetery and the town line on the west side of the road.
 - (c) Larsen Road between Oakridge Road and Clayton Avenue on either side of the road.
 - (d) Maple Lane between Bayview Road and Hunters Point Road on the south side of the road.
 - (e) Nee-Vin Road between Green Valley Road and a point 400 feet west of Green Valley Road on the north side of the road.

- (f) South Park Avenue between South Commercial Street and Bell Street/Maple Lane on either side of the road.
- (g) Tullar Road between Winneconne Avenue and Oakridge Road on either side of the road.
- (h) Michael Avenue between Clayton Avenue and it's termination near Rocket Way on either side of the road.
- (5) Any person violating the provisions above will be subject to forfeiture not less than \$100.00 and not more than \$500.00, and any vehicle parked in violation of this section may be towed at the owner's expense. Each day or part thereof that a violation of this Section occurs shall be deemed a separate violation.

All other provisions of the Town's Code of Ordinances remain in full force and effect.

The Town Clerk-Treasurer and Town Attorney are hereby authorized and directed to take all action necessary to implement this Ordinance.

This Ordinance shall be posted or published in accordance with law.
