By the time you have received and are reading this addition of the town newsletter, we all have enjoyed the Thanksgiving Holiday. And most, if not all town residents have already dealt with the annual event of what to do with fall leaves. You all have heard (read) my thoughts on the fallen leaves of fall. So, I'm going to "leave" that alone. I'm just saying....

On positive notes: I want to thank all of our town voting residents that exercised their right to vote and cast their vote this past November election, voter turnout of 96% of registered voters. Fantastic! With that goes a huge appreciation and thanks to all of our dedicated poll workers and town clerks that put in a full day, I'm talking almost 24 hours, of polling work duties. Thank You, Thank You, Thank you! Also, in the process of voting approvals; I would like to thank all of the town residents that attended the public hearing and approval of our 2025 proposed town budget. For those that may still want to see the 2025 town budget summary, you can request one from the clerk's office during normal business hours. So too, thank you to those same in-attendance town residents for the successful authorization of sale of Town property: 30.55 acres for \$800,000 to Jefferey D. Ogden.

Looking ahead to 2025, the major town investment project is the reconstruction of Larson Road from County Road CB west to Clayton Avenue. Our longrange road improvement plan for this road, as everyone knows, has been advanced, given the construction of the new Neenah High School. As has been stated in previous newsletter articles, we have granted Local Roads Improvement Aid "LRIP" 70%/30% funds to help with this road project. Also, it was recently announced by the state DOT the following:

"RE: ID 6430-24-00, Larsen Road Intersection, WIS 76, Winnebago County: This email is to continue outreach related to the above Wisconsin

Department of Transportation (WisDOT) improvement project at the intersection of WIS 76 and Larsen Road in the Town of Clayton. In late 2022, WisDOT selected a singlelane roundabout as our preferred alternative at this intersection. At that time, we indicated that construction was scheduled for 2026, but we would make every effort to advance this date if possible. Due to the strong efforts of our WisDOT team in working through the design, environmental documentation, right-of-way plat development, utility coordination, and real estate acquisition, we are pleased to let you know that construction for our WIS 76 & Larsen Road roundabout has been advanced into 2025. We anticipate construction will begin in late June/early July 2025 with completion in Fall 2025."

When told of this project in late 2022 and having been awarded LRIP funding for our Larsen Road reconstruction, I started to talk to DOT representatives about the timing of our project and concerns of

construction traffic on our newly constructed road. Whether or not that effort rang true with the higher echelon of the DOT or not, this is great news. Yes, this no doubt will be a commuting challenge for numerous people however it will be all in the same construction calendar year of 2025! The last leg of this road reconstruction "corridor", Oakridge Road from County Road CB east to the Neenah city limits is still projected to be completed in 2026.

So, now we go on to the end of the uproarious year 2024. With that I offer a couple "2024 Fun Facts".



NEXTREX CHALLENGE UPDATE

The recycling challenge is going great! As of November 30th, we have reached 51% of our goal of 1,000 pounds! Keep up the great work. Just a reminder: *All plastic must be clean, dry and free of food residue*. Not sure what is acceptable for the recycling program? Try these tests to see if your plastic is acceptable or not.

- Will the package stretch when you pull it. If yes, it can be included. If it tears like paper, please do not put it in the bin.
- Is the package shiny or does it make a crinkly/crunchy sound in your hand? If yes, do NOT recycle in the NexTrex bin.

Our challenge period runs through June 30, 2025 and have only another 487 pounds to collect to be eligible to win a new park bench.

SUPERVISOR'S INSIGHT

Understanding Property Taxes and Taxing Jurisdictions in the Town of Neenah

Town of Neenah may collect your property taxes, but did you know that the money you pay in property taxes is distributed to several different taxing jurisdictions? Only a portion of what you pay actually stays in the Town of Neenah to fund the annual budget. Each of the jurisdictions use the funds for different purposes, such as education, public safety, and infrastructure. Here's a breakdown of how this works.

A taxing jurisdiction is a governmental entity or district that can levy taxes on properties within a specific area. In the Town of Neenah, there are four taxing jurisdictions:

- 1. Town of Neenah: \$0.07 of every dollar you pay in net property taxes stays in the Town of Neenah. In total, the Town will collect \$553,649 in property taxes to fund the 2025 budget. This portion of your net property tax stays in the Town to help fund the administrative services, fire protection, road maintenance, parks, and recreational facilities Total levy for Town of Neenah = \$553,649.00
- Neenah Joint School District: More than half of every dollar paid in net property taxes (\$0.53) is for Neenah Joint School District. This helps fund public education, including teachers' salaries, school facilities, and extracurricular programs. Total levy on your taxes for Neenah Joint School District = \$3,992,231.25
- 3. Winnebago County: Winnebago County levies its own property taxes to fund regional services such as county-wide health programs, sheriff's departments, or county roads. The county's share of property taxes is \$0.34 of every dollar paid in the Town of Neenah. Winnebago County levy in the Town = \$2,581,794.67
- 4. Fox Valley Technical College. About \$0.06 of every dollar in net taxes is distributed to Fox Valley Technical College for their levy in the Town of Neenah. Total 2024 Levy in the Town for Fox Valley Technical College = \$494,851.12.



For example, a home with a \$250,000 assessed value will pay approximately \$3,856 in net taxes with the following allocation due to each taxing jurisdiction:

There are other items on your property tax bill which impacts the Total Due including first dollar credit, lottery gaming credit garbage, recycling, stormwater and other special charges. For more information about your tax bill visit <u>https://townofneenah.com/property-taxes/</u>.

Understanding your tax bill and where it goes is important. Although you may pay thousands of dollars in taxes, only 7% of your net taxes stays in the Town of Neenah to fund fire protection, road maintenance, road repairs, road construction, parks and trails maintenance and improvements, elections, and the general administrative expenses for the Town of Neenah

<u>Receipts:</u> If you require a receipt, enclose a selfaddressed, stamped envelope with your payment. All payment information and receipts are available on Winnebago County website as soon as payment is posted, you can print tax information for your records.

<u>Refund Policy:</u> If the amount on your mortgage escrow check is larger than the amount of your tax bill, the full amount of the check will be applied to your tax bill and a refund check will be issued within 15 days.

TEXT / EMAIL NOTIFICATIONS TO TAX PAYERS

Winnebago County Treasurer's Office has a subscription feature allowing property owners to receive text and/or email notifications when tax bills are created, tax bill payment is received, tax bill installment payment is due or the tax bill is marked as delinquent. DOG LICENSING

The licensing year for dogs is January 1 – December 31, Licenses for 2025 are now available.

The State of Wisconsin requires that all dogs receive rabies vaccinations by a

veterinarian, and are licensed annually by their local municipality. Be sure to bring a copy of your rabies certificate to the Town Hall when registering your furry friend (a copy is not kept on file).

Licenses obtained after March 31st will be assessed a late fee of \$5.00

How to obtain a license:

By mail: include a completed application (found on our website under Resources—Dog License), rabies vaccination certificate, proof of sterilization, the appropriate payment, and a self-addressed stamped envelope. Once your license has been processed, your certificate and new license will be mailed back.

At the Town Office bring in your rabies vaccination certificate and proof of sterilization, along with the appropriate payment.

SALT & STORMWATER – LEARN ABOUT STORM WATER RUNOFF

Using excess salt harms plants and animals, pollutes our water, damages buildings, and corrodes vehicles, roads and bridges. Once you put salt down, it doesn't go away. Instead, it travels into our lakes, rivers, streams, and wetlands, putting aquatic life at risk and endangering our freshwater resources. Salt also alters the composition of soil, slows plant growth, and weakens the concrete, brick and stone that make up our homes, garages, bridges, and roads.

It only takes 1 teaspoon of salt to pollute 5 gallons of water to a level that is toxic for freshwater ecosystems. We can all work together to promote best practices!

- Shovel: Clear walkways and other areas before the snow turns to ice. The more snow you remove manually, the less likely it is that salt will be needed/the more effective salt will be.
- Sweep: Sweep excess salt from walkways and parking lots after a snow event, especially before a rain event to prevent salt from washing down the storm drain to our waterways.
- Switch: When pavement temps drop below 15 degrees, salt won't work. Switch to sand for traction or a different ice melter that works in lower temperatures.
- *Hire a Trained Contractor:* If you hire a contractor to do your snow and ice removal, <u>check to see if they have attended a Smart Salting</u> <u>training</u>. If not, encourage them to attend <u>an upcoming training</u>.
- Love the lines: The brine stripes on roadways before a storm can reduce overall salt use by 30%! If you see brine lines, you know that your winter maintenance crew is protecting public safety while saving time, money and caring for the environment.
- Be Salt Wise all year! The salt you put in your water softener ends up in local freshwater streams. New, efficient softeners use less than one bag per month. If your softener is using more – have a professional tune it up – or, replace it with a high-efficiency model.

WINTER REMINDERS

OVERNIGHT PARKING - Overnight parking is not permitted on Town of Neenah roads

MAILBOXES and SNOW REMOVAL—My mailbox was hit now what?

- First assess the situation. Was the mailbox damaged by the force of the snow hitting the mailbox or was the mailbox physically hit by the plow equipment? More often than not, damage is caused by the force of the snow. Take some time now to ensure your mailbox is properly installed and secure to withstand the force of snow thrown off the snow plow.
- The mailbox policy states that a damaged mailbox from winter operations will be repaired with a plain standard box when it is evident that the snow removal equipment damaged the box.
- If you believe damage was caused by the snow removal equipment, call the Town of Office to report the damage and the Town will make the necessary arrangement for repair if warranted. 920-725-0916.

PUSHING SNOW ACROSS THE ROAD

- The practice of pushing snow across the road when plowing creates a hazard for the traveling public and creates a problem for the road plowing operation. It is a violation of Town of Neenah Municipal code to 13.06 to plow, shovel, blow, or place snow across any town road into any ditch. Violators will be fined \$50.00 for the first offense with increasing fines up to \$200 for each subsequent violation.
- ♦ This is an issue of public safety, the Town of Neenah and Winnebago County Highway Department requests your cooperation in curtailing this problem.

<u>PETS IN TOWN PARKS</u>: No animals or pets other than leashed dogs are allowed in Town parks. Dogs owners are required to immediately pick up and dispose of excrement on Town park property or adjacent to Town park property.
