## CHAIRMAN'S CHATTER

At the writing of this addition of my Chairman's Chatter, I woke up to 49 degrees at 6:00 am on the 26<sup>th</sup> of August. Felt refreshing, but a full month ahead of our "Fall Equinox" on the 22<sup>nd</sup> of September. This year's Old Farmer's Almanac predicts a warmer, drier autumn for most of the country, but cooler-than-normal and drier conditions for Wisconsin. Conversely, NOAA has an opposite forecast to The Old Farmer's Almanac for Wisconsin of predicting cooler-than-normal fall weather. NOAA's outlook is generally considered more precise, as its forecasts are based on scientific climate data and modeling, rather than the traditional, less scientific methods of the almanacs. I say, there is no such thing as bad weather, only different kinds of good weather. Sunshine is heartwarming, rain is refreshing, wind braces us up, snow is exhilarating. So, whether or not, weather will be weather.

Getting back to things that we hope to be able to control and predict with a degree of certainty.

Our Larson Road reconstruction was "NOT" completed by the beginning of the school year for the High School. By the time you've received this you no doubt know and ask why? Well, the final completion date has been pushed back to October 2nd 2025 due to a delay in the completion of the utility burial project. This includes all related work being executed and completed by We-Energies, Charter/Spectrum, and AT&T respectively. All roadway related work will be finished by the 2nd of October 2025. Our reconstruction Oakridge Road project east of County

Hwy CB easterly to the Neenah City limits is as of this date still on track to be started and completed during the 2026 construction year. However, as in any major road project, there still remains a number of road related issues needed to be firmly determined.

Getting this stretch of Oakridge Road completed concurrently during the 2025/2026 construction time frame would be beneficial to both the Town of Neenah and the City of Neenah, and, the thousands of motorists that use this "Roadway Corridor" on a daily basis.

Many of you have asked about a proposed housing development known that will be called "Homestead Acres". This proposed project will be south of County Hwy JJ and west of the Town of Neenah's Cumming Lane. The Developer/Realtor and the Town of Neenah have held positive meetings in completing a Developers Agreement. At present time this development is to be a condominium development with approximately 38 single family homes on individual home sites.

**FALL BURNING:** As this newsletter gets into the mailbox, the Fall Foliage will begin to turn colors, and the season of FALL will officially be here. This is a reminder that if you intend to burn your leaves, please be sure that the fire is always attended, be mindful of the wind speed and direction so that you do not create a nuisance to your neighbors.

## SANITARY DISTRICT #2 NOTES!

**Televising:** This year the dry spring conditions did not allow for our annual televising. The District Commission works diligently to be great stewards of their finances and decided that the expense to televise later in the year would not be of great benefit nor identify any sources of Influx & Infiltration. We will be monitoring the fall water table, but most likely will need to double up our televising efforts in the Spring of 2026.

**Poplar Court Lift Station 5:** The District cooperated with the adjacent landowner to acquire additional property so that our footprint could be expanded. Poplar court is a private road and many times throughout the year it was often hard to navigate large equipment and maintenance vehicles necessary to the lift station without blocking resident's access of the road. We now have parking and a hard surface for heavy equipment.

# Shoreline habitat

**The water's edge** is a busy place. Northern Pike, bluegills, bass, and other fish spawn in the shallow water along the shore. Loons, ducks, geese, and other water birds nest along the banks. Wildlife such as frogs, otters, and mink live there too. Shoreline areas - on land and into the shallow waters - provide essential habitat for fish and wildlife that live in or near Wisconsin's lakes, rivers and streams

Overdeveloped shorelands can't support the fish, wildlife and clean water that are so appealing to the people attracted to the water's edge.

Unfortunately, that's exactly what's happening to many Wisconsin waterways. The problem is poorly planned shoreland development. Bit by bit, the cumulative effects of tens of thousands of waterfront homeowners "fixing up" their property are destroying one of our state's most valuable resources—it's fragile lake and stream habitats. Some examples:

**Sand trucked in for swimming beaches covers underwater gravel or silt used by**

- fish for spawning
- mayflies for burrowing
- frogs for laying eggs.

**Aquatic vegetation removed to create swimming and boating areas eliminates shoreline-stabilizing plants that are also habitat for**

- bass and other fish that hide among the plants and spawn in areas protected from waves
- loons that nest on floating vegetation
- waterfowl that feed on underwater plants
- insects that live among underwater vegetation.

**Shoreline shrubs and "unsightly" fallen trees are removed to create golf course-type lawns, thus eliminating habitat for wildlife such as:**

- songbirds that use these shrubs for nesting
- ducks that lay eggs in native shoreline grasses
- turtles that sun on fallen logs
- bass and panfish that hide in the shade under toppled trees.

**"If you destroy the natural shoreline habitat then fishing will get worse — and we cannot fix that situation simply by stocking or changing the fishing regulations. If you want great fishing — then you have to protect the fish habitat."**

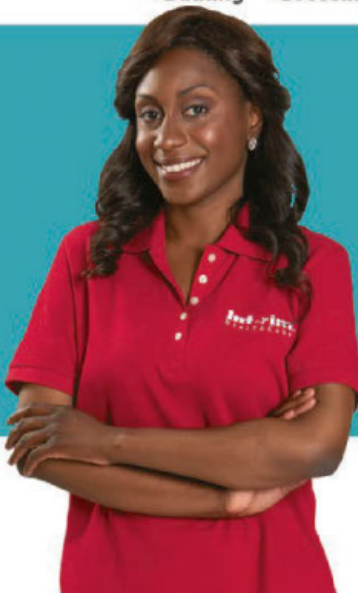

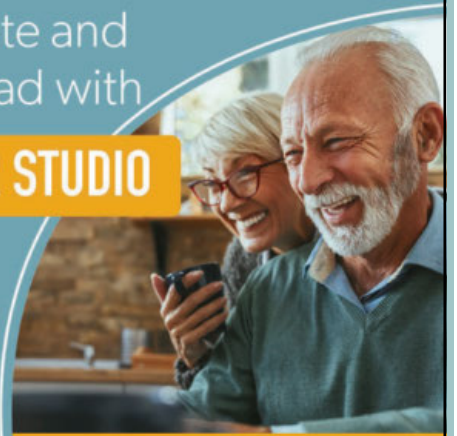

## REVIEW YOUR VEHICLE REGISTRATION to Avoid the City Wheel Tax

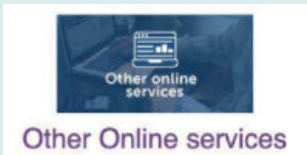
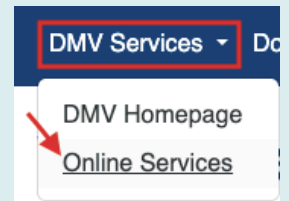
Although this information was shared in the last newsletter, we wanted to communicate it again so you, as a Town of Neenah resident, avoid the \$30 annual wheel tax that has been implemented by the City of Neenah.

As you are most likely aware, the City of Neenah has enacted a \$30 annual wheel tax, an official vehicle registration fee, to fund street and sidewalk improvements. The fee will take effect starting in January 2026 with expected revenue of approximately \$800,000 annually.

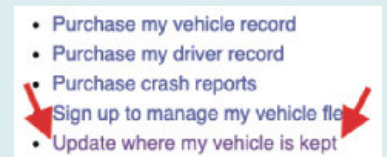
The wheel tax will be collected through the State of Wisconsin DMV at your annual registration renewal. As a Town of Neenah resident, it's important to register your vehicle correctly to avoid the city wheel tax. It's easy to do and if you haven't yet, we encourage you to check now to avoid unnecessary charges on your annual vehicle registration.

To double check your vehicle registration, go to the WisDOT site at <https://wisconsin.gov>.

Once there, click on "DMV Services" and select "Online Services:"



On the Online Services page, click on "Other Online Services:"



Next, in the bullet list of topics, choose "Update where my vehicle is kept:"

After completing the information to find your vehicle registrations, a list of vehicles will appear. Here's the important part; under "Municipality," make sure that "Neenah (T)" is selected:

Another easy way to check your information is to review your License Plate Renewal Notice and verify the information is correct; "Vehicle kept in COUNTY OF WINNEBAGO, TOWN OF NEENAH:



If you find an error on your renewal notice, or are incorrectly charged the wheel tax, report it immediately by contacting WisDOT's customer service at (608) 264-7447. They may be able to issue a refund and correct your record for future renewals. Please reach out to WisDOT for any questions regarding your vehicle registration.

Being proactive and checking your registration will help avoid any incorrect charges and save you time and \$\$\$\$.

# PARKS AND TRAILS UPDATE

Another summer is quickly turning into fall.

The parks and trails in the Town of Neenah continue to see high use. Our shelter rentals have been high with bookings already being made into 2026.

In 2025 we added a playground climber and new bench at Franzoi Park. We also placed a Ginko and Kentucky Coffee tree in the park. Keating park is now enjoying our new bathroom and open ramada shelter.

Conservancy Park Oak Savannah and Northern Prairie restoration is moving forward with WDNR grants to seed the new prairie this fall. This fall we will be doing a prairie cut in lieu of our usual prairie burn. This allows us to remove invasive plants. We will be applying for a new DNR grant for reforestation of our parks and woodland areas in 2026.

As the Town of Neenah completes its road reconstruction, we continue to be mindful of adding safe walking and biking areas along our roadways.

Mahler Park continues to see high usage for soccer, baseball, volleyball, GaGa Ball, Basketball, shelter rentals, and many others enjoying the playground. The Park and Trails committee has been working on a master plan for playground redevelopment, refresh, and fundraising.

Please feel free to reach out to me with any questions, park and trail suggestions, or thoughts on how we can improve our parks. If there are things in particular that you love about your parks and trails, please jump online and give them a positive Google review!

We also have an opening on our Park and Trails Committee. If you love what is happening and want to contribute to continued town progress, please reach out to the town office or myself.

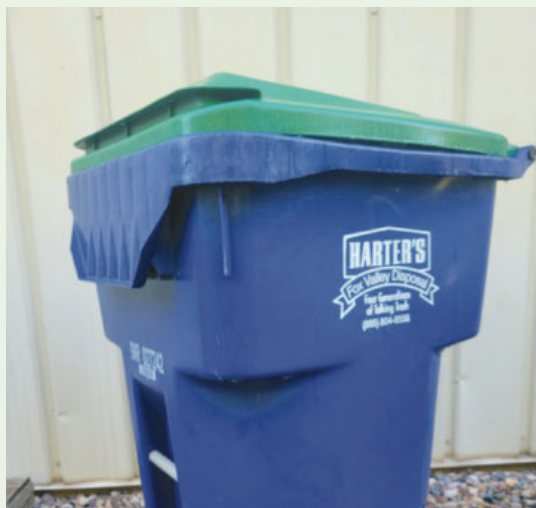

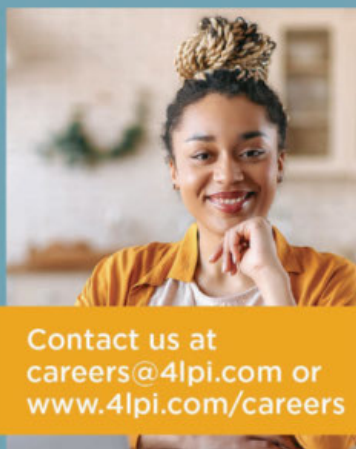

## FALL REMINDERS

- **YARD SIGNS:** Yard signs are NOT permitted in any Town Road right-of-way, including advertisements and political signs.
- **PETS IN TOWN PARKS:** No animals or pets other than leashed dogs are allowed in Town parks. Dogs owners are required to immediately pick up and dispose of excrement on Town park property or adjacent to Town park property.
- **ROAD RIGHT-OF-WAY WORK:** Work in the Town road right-of-way (other than mowing) must be permitted through the Clerk's office prior to any work being performed.
- **BURNING:** Remember burning is permitted in the Town as set forth in Ordinance 5.05. Be respectful of your neighbors when burning. Contact Winnebago County Sheriff before and after burning (920)236-7300 #0 to avoid false alarms.
- **STREETLIGHT OUTAGE** - report to WE Energies on their website for streetlight outages or contact the Town Hall with location of streetlight.
- **MAILBOXES** - Ensure your mailbox is properly installed and secure to withstand the force of snow thrown off a snow plow during the winter season. If the snow thrown from the equipment damages your mailbox, it is your responsibility to replace the mailbox.
- **ADDRESS SIGNS** - keep your brown address sign in front of your home clearly visible at all times, make sure there is no overgrown brush, grass or tree branches blocking the view of your address sign. These signs insure that police, fire and rescue will locate your property quickly in the event of an emergency.
