**Old Business**

- B. Cardoza thanked Fire Chief Osero for including the Town Board in the Firefighters Appreciation Dinner and she congratulated all those that received an award.
- E. Skerke noted that the pending annexation and a potential Certified Survey Map was discussed at the Plan Commission, with Winnebago County Zoning and City of Neenah Community Development. All agreed that it was best to allow the annexation to go through the process and let the City manage the CSM. There will be no further action needed at the Town level. Winnebago County Zoning Department will verify that the legal descriptions on the annexation and CSM are correct.
- M. Parmentier provided an update to the Board regarding the property on South Park Avenue. The agreement with the property owner was signed on 11-4-25, giving him 60 days for compliance. Winnebago County Zoning issued a violation letter giving a deadline of June 1-2026 for compliance. At the February 23<sup>rd</sup> meeting, the Town Board will discuss the Towns next steps.

**New Business**

- E. Skerke noted that that Wisconsin Towns Association is offering District meetings which include Board of Review training. At least one Board member needs to be trained this year, preferably more than one is trained since 2026 is a revaluation year.
- D. Bluma noted that the property at 1295 CTH JJ and what appears to be a new structure being built.



The resignation of Brett Armstrong in 2025 left a vacancy on the Plan Commission. The position was advertised through the Town newsletter and website. Residents were invited to apply via the newly established formal application process.

Two applications were received for the position: Edmund King and Andrea Madsen. (Full application files are available in the office upon request.)

On Wednesday, January 28, Plan Commission Chair Jody Andres and Town Board Supervisor Dave Bluma met to evaluate the candidates. Supervisor Jim Weiss, while unable to attend in person, provided his input via discussion with Supervisor Bluma the evening prior.

Upon reviewing the credentials of both applicants, the group determined that their qualifications were sufficiently detailed to make a decision without the need for individual interviews.

While both candidates have impressive credentials, the committee reached a unanimous decision to recommend the appointment of Andrea Madsen to the Plan Commission.

Andrea Madsen lives at 1516 S. Park Avenue, she has a master's degree in public administration and is currently pursuing her PhD in Philosophy, focusing on individual well-being and community land use.
